## IMO CONTINUES TO SUPORT IMLI'S ACTIVITIES

The IMO International Maritime Law Institute (IMLI) was established in 1989, under the auspices of the International Maritime Organization (IMO). IMO is a specialized agency of the United Nations, which is responsible for measures to improve the safety and security of international shipping and to prevent marine pollution from ships. It is also involved in legal matters, including liability and compensation issues and the facilitation of international maritime traffic.

The International Maritime Organization (IMO) has no provision in its regular budget for the support of IMLI, but it has been nonetheless helping the Institute in various manners throughout the years. A very important mean for supporting IMLI's efforts by IMO, is to provide scholarships for deserving lawyers, especially from developing countries, to study at IMLI.

Last year, 8 (eight) students from all over the globe were sponsored by the IMO Technical Cooperation Fund, which allowed them to graduate in international maritime law at the IMO International Maritime Law Institute.

In the current academic year another 6 lawyers, from 6 different States, are benefiting the IMO Scholarship at IMLI.
