

The major aim of the project is to contribute to the promotion, adoption, effective implementation and enforcement of international maritime conventions adopted under the aegis of the United Nations (UN) and of the International Maritime Organization (IMO) and to encourage a greater participation by developing States, particularly Asian, in the major international maritime law conventions and legal instruments.

The realization of this project, administrated by IMLI, would not have been possible without the generous contributions of funds by the Nippon Foundation.

An important feature and integral part of this project is to provide scholarships for deserving lawyers from developing countries, especially from the Asia region, to study at IMLI.

In the previous academic years 17 lawyers from all over the globe were awarded Nippon Foundation Scholarships to pursue a postgraduate training in International Maritime Law at the IMO International Maritime Law Institute in Malta.

Another important part of the project is the "Sasakawa Prize for the Best Performing Nippon Foundation Scholars" which is awarded every year to the Nippon Scholar, who has the best overall performance in the LL.M. Programme. The 2005 Sasakawa Prize was presented at the 2005 Graduation Ceremony to Ms. Rusudan Tushuri (Georgia).

This year another 8 lawyers from 7 different countries are benefiting from the Nippon Foundation scholarship at IMLI.
