KEY NOTE ADDRESS DELIVERED AT THE 1998 IMLI GRADUATION CEREMONY BY H.E. MR. WILLIAM A. O'NEIL, SECRETARY-GENERAL OF THE INTERNATIONAL MARITIME ORGANIZATION

am very pleased to be present once again at the Graduation Ceremony of the IMO Inter national Maritime Law Institute. A graduation ceremony is always a happy occasion not only for the graduates, but also for those who are no doubt eagerly looking forward to their return home and putting all that they have learned into practice.

IMO's success in promulgating International Conventions and other legal instruments needs to be complemented by national implementation and enforcement of the rules and standards which they contain. However it became evident that many IMO Members were unable - largely due to a lack of qualified legal experts - to analyse the Treaties and Agreements and introduce them into national regulations that they could then be properly implemented.


It was with this in mind that IMO established the International Maritime Law Institute nearly ten years ago. The purpose of the Institute is to provide a means whereby lawyers from various countries can be trained in International Maritime Law and in particular obtain a better understanding of how to write appropriate national laws and regulations.

164 candidates from 73 countries have been trained at IMLI. The success achieved by these graduates is to a large extent a reflection of the quality of those chosen and also of their thorough training here. I am very proud to know that IMLI graduates are occupying such posts as Ministers of Justice, Attorneys General, Chief Justices and Ambassadors, while others occupy important positions in their maritime industries' infrastructure.

IMLI is funded through voluntary contributions and student fees. I would like once again to record my appreciation for the continuing support from those donors who have contributed either by donations to the Institute's general fund or by the donation of fellowships. IMO has a very limited amount of money for direct technical assistance, nevertheless we have already provided three fellowships from our Technical Cooperation Fund.

I would also like to say how commendable it is that developing countries themselves are participating actively in the funding of IMLI. This development has increased over the last five years as more and more Governments are seeing for themselves the excellent training the graduates have received here in Malta. We have reached the point where there is practically no major port in the developing world where the shipping community cannot find the services of a local lawyer trained in International Maritime Law.

IMLI was one of the first institutions of the United Nations system to reserve 50% of its places for women and this year we had eight female students. We recognize the importance of this and

will continue to promote the study of Maritime Law amongst women lawyers.

In the next academic year, the Institute will celebrate its tenth anniversary. At the start of its life, there were some doubts as to the probability of its success, however, in view of the high quality of its graduates, these doubts have disappeared and there is widespread recognition of IMLI's role in advancing Maritime Law internationally. This achievement is due to the quality of the teaching and to the dedication and hard work of the students and graduates. I would especially note the excellent leadership provided by Professor Attard and the high quality of the lecturing by Simon Kelley. We, of course, could not provide training on the broad range of topics which are covered without the voluntary assistance provided by the visiting lecturers to whom we extend our heartfelt thanks.

Mr. President, I would also like to give special recognition and thanks to the Government of Malta which continues to show consistent interest in and support to the Institute.

Finally, to the graduates of the ninth course, I wish you the very best for your future. I offer to all of you the congratulations of IMO and myself. The Master's Degree you have been awarded is of course a recognition of your high qualifications and competence in the field of Maritime Law which can now be applied to assist in the implementation of IMO's global standards for safer shipping and cleaner seas.

The Malta Maritime Authority recently made a very generous donation to the International Maritime Law Institute to help in the extension of the Institute's premises, and for the further expansion of the Institute's library which is already recognized as the largest comprehensive specialized maritime law library in the Mediterranean region.

The presentation was made on behalf of the Malta Maritime Authority by the Hon. Mr. Censu Galea, the Maltese Minister for Transport and Communication, during an official visit to the International Maritime Law Institute on the occasion of the commemoration of World Maritime Day, on Thursday 24th September 1998. Minister Galea also met the 19 lawyers coming from 15 different countries including Malta who are following this year's academic course at the Institute, leading to a Master's Degree in International Maritime Law.

#### VALEDICTORY ADDRESS AT THE IMLI GRADUATION CEREMONY 1998 BY MR. NAGANTHAN SIVAHUMARAN (SRI LANKA)



T is said that the peculiar characteristic of learning is that it is a double source of pleasure, an intrinsic joy to him who has the knowledge, and a source of happiness to others who benefit by it. A poetic composition of great antiquity in the Tamil literature has it: The office of learning is to make the mind penetrating, lofty and rich with information.

The academic year 1997/98 marks the turn of the 50th year of the International Maritime Organization, the parent body of this Institute which itself celebrates the completion of a decade. It is perhaps as a mark of appreciation of service rendered by the IMO to mankind, that this year has been declared by the United Nations the Year of the Oceans.

I come from an island known as the Pearl of the Indian Ocean - Sri Lanka. The word ocean triggers my mind to an abiding and fascinating legend of India - Samudra Manthan, the churning of the oceans by the Gods and demons in the heavens. Using a mountain as the churning pole and a serpent king as a rope, they wanted to bring forth Ambrosia, the

elixir of immortality, from the oceans. From this churning of cosmic proportions, the legend goes, there emerged many an element: poison, animals, a tree, a gem and even a goddess. The Ambrosia did appear, but only at the end.

The International Maritime Law Institute with a team of Professors, lecturers and professionals of varying disciplines has conducted a Samudra Manthan of a sort: a churning of the minds of a group of students coming from all parts of the world, for the past nine months. The process unfolded with our catching a glimpse of the ancient history of maritime law as Dr. Muller - who, we are glad, is here with us today - holding sway in his inimitable fashion. The whole exercise was brought to a close, after a hot pursuit just a few weeks ago by our Professor.

But this churning is of international proportion to bring forth, what I daresay, a rare feat that was best described by none other than our Director, Professor Attard: There will practically be no major port in the developing world, where you will not find an IMLItrained maritime lawyer or as I prefer to describe our graduates, an apostle pursuing the goals of safer shipping and cleaner seas.

#### VISIT BY MINISTER

This year is the 50th Anniversary of the adoption of the International Convention establishing the International Maritime Organization which is the United Nations Specialized Agency for maritime affairs. The importance of this commemoration is borne out by the fact that 1998 was chosen by the UN as the Year of the Oceans. For Malta this year is also momentous because it marks the 25th Anniversary of the promulgation of the Merchant Shipping Act of Malta.

Malta has been a member of the International Maritime Organization since 1966, after having acceded to the UN Convention establishing the Organization in June of that year. Since then Malta has ratified the major IMO Conventions and is today an active member within IMO, particularly in the light of its responsibilities as an international maritime centre, being one of the five main shipping registers in the world.

Minister Galea pointed out that Malta acknowledges the important role that IMO has in ensuring safe navigation and the protection of the marine environment. He further stated that Malta is proud of its close association with IMO which is borne out by the two important international centres run by IMO in Malta: the Regional Marine Pollution Emergency Response Centre for the Mediterranean Sea, and the International Maritime Law Institute. integration of the maritime culture in the light of modern knowledge and to suit our present day needs, and the resuscitation of its fundamental values in their pristine vigour.

The Institute relentlessly seeks, by the dissemination of knowledge, the harmony of nature and human relations, not in any make-shift way, but within the frame-

work of the maritime order. It pursues the goal of unification in diversity, through a common medium of understanding.

I shall now turn to safer ships. Sailing has always been a daunting vocation. However it is they that go down to the sea in ships that do business in great waters. There has always been a ceaseless tussle between the irresistible desire of man to be master of ocean and the ocean's strength to expose human weaknesses. We have come a long way from Titanic to safer ships. But one may safely assume that the new millennium will throw new challenges and demand greater understanding in the field of shipping as in any other

It is in some sense unreasonable in us to be constantly discontented with a condition which is constantly improving. But, in truth, there is constant improvement precisely because there is constant discontent. If we are perfectly satisfied with the present we would cease to contrive, to labour and to improve with a view to the future. So our pursuit of improvement must continue and never cease. The threat to the health of the oceans is real and ever-present with momentuous discoveries on the sea-bed and elsewhere. Science has opened immense realms to man's imagination, not all of them with potentialities for a greater happiness of mankind.

We entered the portal of this Institute with a mission in our minds. It is a mission to render ourselves competent in International Maritime Law so that our respective countries may be better served. Today we bid adieu to our academic struggle as we celebrate the accomplishment of our mission. Though we have earned the right to be jubiliant, we owe our achievements to those who have made it all possible: to our respective sponsors and Governments, the International Maritime Organization which is represented by His Excellency the Secretary General himself in whose company we are, the Commonwealth Secretariat, the United Nations Development Programme, the Government of Malta, the Comitè Maritime International and to companies such as GNMTC of Libya and other organizations, institutions and individuals who have assisted us throughout our stay at the Institute.

Last but not least, we do remember the tremendous sacrifices made by our families, spouses and children,


### MESSAGE TO IMLI FROM SECRETARY-GENERAL OF IMO


