KEYNOTE ADDRESS DELIVERED AT THE 14th ANNUAL GRADUATION CEREMONY BY H.E. MR. WILLIAM A. O'NEIL, 17 MAY 2003

It is also a pleasure for me to welcome you to this ceremony and I am pleased to have this opportunity to address the graduating class of 2003. I would also like to thank Professor Attard for his kind words, and to assure him that my strong personal interest to this fine Institute will not diminish when I step down as Secretary-General of IMO at the end of this year.

First of all, I would just remind you who are graduating today that the primary objectives of IMO are to bring about genuine improvements in the safety and security of international shipping and to the prevention of marine pollution and that its success in achieving these goals depends to a considerable extent on skilled maritime lawyers whose ranks you have now joined.

That is because developing the international regulatory framework that can yield such improvements is only one half of the story—the other is the highly specialized job of drafting the necessary practical and enforceable national laws without which the internationally agreed standards simply would not be effective.

This Institute was established by IMO to ensure that Governments would have trained maritime legal experts available who could incorporate the often complex international maritime legal framework of rules, codes and standards into national legislation.

Take, for example, the measures adopted by IMO to address the issue of maritime security worldwide which became necessary after the terrorist attacks on The United States in 2001. IMO convened a diplomatic conference last December which resulted in the adoption of amendments to the SOLAS Convention, which will enter into force on 1 July 2004. The requirements of the SOLAS amendments and the new International Code for the Security of Ships and of Port Facilities must be integrated into the regulatory framework of each member State, so that the entry into force date next year can be met. This is a major challenge and one which I am sure many of you may become involved in as you begin or continue your careers in maritime law.

As Professor Attard mentioned, IMLI's progress over the years has been dependent upon the continuing support received from donors who have contributed either to the Institute's general fund or by the provision of fellowships, and I would like to take this opportunity to add my thanks to them for this most valuable assistance. I look forward to a continuation of this vital aid, and I am confident that the consistently high quality of the graduates, which is widely recognized and acknowledged, will encourage additional development partners and recipient countries to contribute to the excellent training that is being offered here in Malta.

We also are especially indebted to the Maritime Authority of Malta for its continued assistance. 
H.E. Mr. William O'Neil said that he was pleased and impressed to see the improvements in the building. IMLI's spectacular growth warranted

IMLI - NIPPON FOUNDATION JOINT PROJECT FOR ADVANCEMENT OF A NEW LEGAL ORDER ON THE WORLD'S OCEANS


IMLI and the Nippon Foundation recently launched their joint Project for Advancement of a New Legal Order on the World's Oceans. The Project is the product of fruitful collaboration between the two organizations and is made possible through the generous financing of the Nippon Foundation.

The Project is administered by IMLI and is intended to contribute to the promotion, adoption and effective implementation and enforcement of international maritime rules and standards, as well as to encourage a greater participation by developing States in the major international maritime law conventions and legal instruments.

The Project provides scholarships funding for deserving candidate lawyers to carry out specialized studies in international maritime law within the Master of Laws Programme offered by IMLI.

This year a total of nine candidates have been awarded the Nippon Foundation Scholarship to pursue their LL.M. studies at IMLI. These are: Mr Alamgir Khan (Bangladesh), Ms Marija Pospisil (Croatia), Mr Etueni Caucau (Fiji) Mr Takashi Arikawa (Japan), Mr Tajudeen Giwa (Nigeria), Mr Amos Kirio (Papua New Guinea), Ms Saowalak Jullamon (Thailand), Mr Igor Karaman (Ukraine), and Ms Chola Shapi (Zambia).

It is expected that through this Project developing States across the globe will be able to participate in a meaningful manner in the harmonization

DOCTOR OF PHILOSOPHY

The Doctor of Philosophy (Ph.D.) programme is seeing a steady flow of candidatures from around the globe. The degree may be awarded following successful defense of a thesis of not more than 100 000 words on a subject within the syllabus of the Institute.

The Ph.D. programme is solely research-based and involves a high degree of independence from candidates. Thus, the programme can be largely undertaken from abroad. The Institute will appoint a supervisor from a list of internationally-

Studies for the degree are to extend over a period of not less than three and not more than five years.

Prospective candidates must hold a Master's degree from a recognized university or other academic institution, or qualifications of comparable standard including relevant professional legal experience recognized for this purpose by the Institute.

MASTER OF LAWS IN INTERNATIONAL MARITIME LAW

IMLI offers a unique opportunity of specialized and intensive training in one of the growth areas of international law. Its one academic year programme, leading to the degree of Master of Laws (LL.M.) in International Maritime Law, consists of education in international law, law of the sea, shipping law, marine environmental law and the drafting of maritime legislation. The course is delivered by IMLI's resident faculty, supplemented by eminent visiting lawyers and academics.

This unique course is most suitable for persons already working in the maritime field such as with a relevant Government department, shipping company, port authority or other organization concerned with shipping and maritime affairs. Persons wishing to pursue a career in the field of international maritime law will also benefit immensely from the course.

Admission to the course is open to a limited number of students in any academic year, thereby ensuring personal intensive guidance and supervision. A university degree in law as well and proficiency in the English language are pre-requisites.


Applications are now invited for the 16th annual LL.M. course, scheduled to begin on 13th September 2004. Financial aid may be made available.
