# WORLD MARITIME DAY 2006 CELEBRATED AT IMLI

On World Maritime Day 2006, IMLI had as special guest, the Honorable Censu Galea, Minister for Competitiveness and Communications, Malta.

The following are excerpts from Minister Galea's address to the students:

"Once again it is my great pleasure to mark World Maritime Day together with yet another group of students of the International Maritime Law Institute, IMO's premier institution for maritime law training.

"Since its inception in 1988, IMLI has trained over 360 lawyers in international maritime law. With this 18<sup>th</sup> intake, we have with us today for the first time students representing Jordan and Kazakhstan, bringing the total number of nationalities represented by IMLI graduates together with this year's future graduates to 109 States, territories and land areas spread around the globe. This year also marks the intake of an unprecedented 35 new students, the largest class ever. An outstanding achievement and an irrefutable proof that IMLI is living up to its motto of "serving the rule of international maritime law."

"Malta is truly proud of hosting such an important institution. It is a continuation of Malta's continuing commitment for the promotion of international co-operation in the global pursuit for safer seas and cleaner oceans.

"This year's theme for World Maritime Day is "Technical Cooperation, IMO's response to the 2005 World Summit". As the IMO Secretary-General pointed out in his message, it is indeed a theme befitting the Organisation's raison d'etre – that of being a service provider not only to the maritime community but also in the wider context of the international agenda set by the United Nations in the Millennium Declaration.

"Six years ago, the adoption of the Millennium Declaration by the General Assembly of the United Nations was a defining moment for global co-operation in the 21<sup>st</sup> century. The Declaration set out the key challenges facing humanity and established measures, known as the Millennium Development Goals to meet these challenges.

"Maritime activity has a key role to play in the eradication of extreme poverty and hunger. It already provides an important source of income and employment for many developing countries through

activities such as the registration of vessels, the supply of manpower, shipbuilding and repair, and port services.

"When seen in a wider context, shipping has an even more important role to play as sea transport remains by far the most costeffective way to move goods and raw materials around the world and the vast majority of global trade is carried by ship. It is important to emphasize however, that developing countries not only partake in this global activity but also carry out their obligations as members of the wider maritime community.

"Environmental sustainability in shipping is a central theme and thus it is completely in line with the corresponding development goal as evidenced by the IMO's motto "Cleaner Seas – Safer Oceans".

"As far as the environment is concerned, shipping – represented by the world body IMO – makes a notable contribution thanks to the comprehensive array of measures developed and adopted by the Organisation and put in place by its Members and the industry. Enhancing marine environment protection along the coasts leads to improved fishing catches of the non-industrial kind prevalent in developing countries, cleaner waters and coasts, increased tourism and improved integrated coastal zone management.

"The Green Paper on Maritime Policy is presently being discussed at European Union level. Commissioner Joe Borg has come forward with a proposal that can be applied worldwide, even though it originated from one particular region.

"The year long consultation period on this green paper coincides with your presence at IMLI. I believe that during the coming months you will have the opportunity to discuss in certain depth, the contents and relevance of this paper to both European and international maritime activities.

"A final note that concerns you as future alumni of this Institute, I am sure that your varied experiences will, during the coming months, help you both individually and as a group, to broaden your maritime experiences. Within a few months you will all be better prepared to face the challenges that maritime activities bring about, sometimes unexpectedly."

#### SWISS GOVERNMENT FUNDING FOR IMLI

## IMLI-ITF SEAFARERS' TRUST JOINT PROJECT FOR "THE HUMAN DIMENSION IN INTERNATIONAL MARITIME LAW: SEAFARERS' RIGHTS"

IMLI and the International Transport Workers' Federation's Seafarers' Trust (ITF Seafarers' Trust) are working towards the establishment of their Joint Project relating to "The Human Dimension in International Maritime Law: Seafarers' Rights".

The Project is intended to provide for the promotion, adoption and implementation of international maritime rules and standards relating to seafarers' rights. The Project will be undertaken in two phases. The first phase will focus on the consolidation of the Institute's ongoing programmes on international maritime labour law, and will involve the setting up of dedicated, specialized research facilities on seafarers' rights. The second phase of the project will then focus on the provision of two scholarships to deserving senior legal government officials to pursue studies at IMLI's LL.M. Programme during the academic year 2007-2008.

The Project is the product of a long-standing collaboration between the two Institutions, during which the ITF and the ITF Seafarers' Trust have provided scholarship funding for deserving candidates to pursue LL. M. studies at IMLI. The beneficiaries of these scholarships have been: Ms. Krasimira Danailova (Bulgaria), Ms. Lia Paresahvili (Georgia), Ms. Josephine Nkrumah (Ghana), Mr. John Kouni (Solomon Islands), Mr. Michel Amafo (Suriname), and Ms. Margarita Rodriguez Salaberry (Uruguay).

The ITF is an international trade union federation of transport workers' unions. Its membership includes 681 unions representing 4,500,000 transport workers in 148 countries, and has been helping seafarers since 1896. Today it represents the interests of seafarers worldwide, of whom over 600,000 are members of ITF-affiliated unions.

### **IMLI ACADEMIC PROGRAMMES**

Applications to the following academic programmes are now being invited:

**DOCTOR OF PHILOSOPHY PROGRAMME** – The Programme is solely researched-based and involves a high degree of independence from candidates. It requires the submission and successful defense of a thesis of not more than 100,000 words. Studies for the degree should be completed within three to five years from first enrolment. To qualify for the Programme, candidates must hold a Master's degree from a recognized university or academic institution, or hold qualifications of comparable standard.

MASTER OF LAWS IN INTERNATIONAL MARITIME

**LAW** – The one-year study Programme consists of education in international law, law of the sea, shipping law, marine environmental law, and drafting of maritime legislation. Admission to the Programme is open to a limited number of students in any academic year. A university degree in law and proficiency in the English language are pre-requisites to admission. Financial assistance may be available.

**ADVANCED DIPLOMA IN INTERNATIONAL MARITIME LAW** – The Programme requires the candidate to earn a total of 25 credits by successfully following and completing credits on distinct subject areas either within the Public International Maritime Law strand, the Private International Maritime Law strand or the General International Maritime Law strand. Credits must be undertaken between one to five academic years from first enrolment.
