## LIBYAN MARITIME AUTHORITY PRESIDENT VISITS IMLI

The Institute welcomed on 9 January 2014 Mr. Sharafeddin Banghazi (President of the Libyan Maritime Authority) who paid an official visit to IMLI and met with the students of the Class of 2013/2014.
