26th ANNUAL LL.M. PROGRAMME COMMENCES

IMLI's 26th Master of Laws (LL.M.) programme in International Maritime Law commenced on Monday 13 October, 2014. During the academic year 2014/2015, thirty-three lawyers from twenty-seven countries will pursue their LL.M. studies at the Institute. Morocco is being represented for the first time in the Institute's LL.M. programme. In addition, the Institute has several candidates from several countries, including Oman, Nigeria, the Gambia, India, Russia and Malta, who will attend its Advanced Diploma Programme in International Maritime Law and its short courses in the various areas of both Shipping Law and the Law of the Sea.
