## INDONESIAN ACADEMIC APPOINTED AS THE NIPPON FOUNDATION LECTURER ON INTERNATIONAL MARITIME SECURITY LAW

The Institute is pleased to announce the appointment of Ms. Atur Tetty Lubis, an academic from Indonesia, as The Nippon Foundation Lecturer on International Maritime Security Law.

Ms. Lubis was awarded a cum laude degree in Bachelor of Laws (LL.B) by Gadjah Mada University, Indonesia, in February 1998, where she majored in International Law. In 2009, the UK Government awarded her the prestigious Chevening scholarship to pursue a Master of Laws (LL.M.) degree at University College London. She took a specialization in maritime law and graduated from said University in 2010. During her studies, Ms. Lubis joined an internship programme at IMO's Headquarters in London, where she also assisted the Indonesian Embassy in London to conduct research in areas of Law of the Sea and Shipping Law. In May 2016, Ms. Lubis obtained a Master of Business Administration (MBA) degree in Strategic Management from Monash University, Australia. She won the second prize in the inter-collegiate debate competition organized by the World Trade Organization and the University.

Ms. Lubis started dealing with maritime issues since she was employed as a junior officer in the Indonesian Port Corporation, a State-owned company managing and operating the commercial ports in central and eastern Indonesia. During her nine year tenure with the company, she was assigned to be the country's representative at annual ASEAN's port and harbor meetings and was appointed as a member of the APA's working committee.

Ms. Lubis also worked as an assistant for investor engagement for United Nations-supported Principles for Responsible Investment (PRI) in London, where she was involved in a number of projects in environment and governance. In 2012, she joined BINUS University International/BINUS Business School as a faculty member. She was later appointed as the Subject Content Coordinator for International Business and Law Program at the University.

Ms. Lubis had been a Visiting Lecturer at Chitkara University, India and Gadjah Mada University, Indonesia. She has also facilitated numerous trainings and short courses in International Law, Export-Import and Ethics in Indonesia and East Timor. Her legal knowledge has been extended to practicality when she joined a law firm in Jakarta as a Senior Counsel, specialized in Maritime Law, International Law and Alternative Dispute Resolution.
