## **IMLI HOLDS ITS 28TH ANNUAL GRADUATION CEREMONY**

The IMO International Maritime Law Institute (IMLI) held its 28<sup>th</sup> annual Graduation Ceremony on Saturday 27 May 2017 at the Malta Maritime Museum, Vittoriosa. Two more students were awarded an Advanced Diploma in International Maritime Law and one student was awarded the Degree of Magister Juris (M.Jur.) in International Maritime Law.

In his address, Professor David Attard (Director, IMLI) welcomed the dignitaries to the graduation ceremony and invited Mr. Kitack Lim (Secretary-General, IMO), who delivered the graduation address. The Valedictory Speech was delivered by Ms. Sunita Shenelle Roberts (Trinidad and Tobago) on behalf of the IMLI Class of 2016-2017.
