DIRECTOR OF THE SEAMEN'S CHURCH INSTITUTE (SCI) CENTER FOR SEAFARERS' RIGHTS LECTURES AT IMLI

Mr. Douglas B. Stevenson (Director of the Center for Seafarers' Rights at the Seamen's Church Institute (SCI) of New York and New Jersey, USA) visited the IMO International Maritime Law Institute (IMLI) on 25-26 January 2018 and delivered a set of lectures on Seafarers' Rights and the Maritime Labour Convention to the IMLI Class of 2017-2018.

Mr. Stevenson opened the class by emphasizing the importance of studying seafarers' rights. He gave a unique view on the biggest threat to Maritime Security, a focus point to many studies and discussions for many years in maritime international law. He stated that contrary to popular belief, piracy is not the biggest threat to Maritime Security. Maritime Security is primarily concerned in ensuring that the Sea Lines of Communication (SLOCs) are open. To effectively accomplish this,

vessels traversing the SLOCs need to be manned by skilled seafarers. However, as of late, there has been an increase in concern over the growing shortage of skilled seafarers. This he believes must be addressed by way of ensuring that seafarers are cared for and attractive packages are given to them make a career at sea more enticing and for more skilled seafarers to enter the workforce.

Thereafter, he divided the class into seven groups. His method of teaching is more on the interactive approach where students are encouraged to participate in the discussions on the topics in interest for the said session such as: the Rules of International Maritime law in general, its effect to seafarers' rights and the Basic Fundamental Seafarers' Rights.

He serves as President of the Life Saving Benevolent Association of New York and is Past Chairman of the International Christian Maritime Association. He is a graduate of the U.S. Coast Guard Academy and the University of Miami Law School.
