ANKARA UNIVERSITY PROFESSOR LECTURES AT IMLI

Professor Dr. Hakan Karan (Director of the Research Center of the Sea and Maritime Law, Ankara University, Turkey) visited the IMO International Maritime Law Institute (IMLI) on 27 March 2018 and delivered lectures on "Irregular Migration At Sea" and "The Legal Regime of the Turkish Straits" to the IMLI Class of 2017-2018.

In his lecture, on "Irregular Migration At Sea", Dr. Karan emphasised that Migrant Smuggling is a problem closely intertwined with Irregular Migration, and as such, these two must be discussed

together. He then went on to discuss migrant smuggling as a criminal act, contrasting it with the entry or residence of migrants, related human rights considerations and the legal mechanisms in international instruments to provide protection to the Migrants at Sea. He engaged the students with an insightful discussion on the Turkish experience, which the students appreciated greatly as Turkey, due to its geographical location, have many experiences in this issue in recent years. He ended his lecture, citing co-operation between states is crucial to protect human rights at sea and combat problems on migration at sea at the same time.

In his lecture on "The Legal Regime of the Turkish Straits", he discussed the relevant provisions of the UNCLOS and the Montreux Convention of 1936. He likewise iterated the rights of merchant and warships in the Turkish straits and the legal bases thereto.

Prof. Dr. Hakan Karan, LLM, Ph.D., Attorney at Law, is the Director of the Research Centre of the Sea and Maritime Law (DEHUKAM) at Ankara University and the Head of the Sea and Maritime Law Department at the Law Faculty of Ankara University as well as a Legal Advisor to the Turkish Ministry of Foreign Affairs. He read for a Ph.D at London Metropolitan University on the International Carrier's Liability under the Hague, Hague-Visby and Hamburg Rules. He regularly attends the meetings of the IMO Legal Committee as a Turkish Delegate. He is also a member of the Customs and Trade Facilitation Commission of ICC. He was also a member of the Drafting Committee responsible for the Vth Book (Maritime Law) of the New Turkish Commercial Code 2011. He writes and lectures in the field of the International Law of the Sea, International Maritime Law, International Trade Law and the Law on International Carriage of Goods.
