UNIVERSITY PANTHÉON SORBONNE PROFESSOR LECTURES AT IMLI

Geneviève Bastid-Burdeau is a Professor of international law at the University Panthéon Sorbonne (Paris I). She obtained her doctoral degree - Docteur d'Etat en Droit Public at the University of Paris II. She is also a member of the Institut de Droit International and a Former Secretary General of The Hague Academy of International Law.

Professor Bastid–Burdeau began her academic career as the Assistant at the University of Paris II and at the University of Dijon. He became Professor at the Faculty of Law of the University of Dijon (1975-1992) and she also held a Professorship at the Institut d'Etudes Politiques de Paris (1988-93). Since 1992 she has been a Professor at the University Panthéon-Sorbonne -Paris I. She lectures at various universities around the world, including Switzerland, China, Japan, Germany, Angola, Nigeria, Poland, Czech Republic, Argentina, Brazil, Chile, Egypt, Italy, Spaign, Sweden and this has been her first visit to IMLI. Along with her academic career, Professor Bastid–Burdeau has been a member of consulting groups for the Legal Advisor of the French Ministry of Foreign Affairs and a consultant for several states, international organizations and law firms. She participates in a number of distinguished national and international institutions and organisations dealing with international law, including the Institut de Droit International, the International Law Association she has also been a Member of the Board and Deputy-chairperson of the French Society for International Law, etc.

Professor Bastid–Burdeau publishes frequently on topics concerning international law and international relations in various national and international specialised publications and periodicals.
