

## MARITIME SECURITY SEMINAR AT IMLI

Major (Retd) Anthony Hall and Mr. Kevin Green (Secure Leadership Selector) delivered recently a two-day seminar on maritime security to the IMLI Class 2009/2010. The seminar, a key subject within IMLI's course on Maritime Safety and Security, aims to explain to its participants the legal implications and practical aspects of maritime security which together form a coherent whole for the protection of life and property at sea.

The seminar introduced the students to the procedures and processes necessary for the assessment of risks. It focused on the need to understand the threats that the maritime industry faces and the response given by States through the creation of international regulations and policies that cover maritime security as well as the national regulations that have been imposed. The importance of the ship security assessment, its relationship to the ship security plan, and the necessity for port security measures were also extensively explained and demonstrated during the seminar.

During the discussions on the Company and Ship Security Officer Training, IMLI students were exposed to theoretical situations and practical exercises wherein they could apply the knowledge imparted to them during the seminar.

Major Anthony Hall was previously with the Royal Air Force and later transferred to the Intelligence Corps of the British Army where he served for 24 years. During his career, his primary areas of expertise were counter-intelligence, protective security, intelligence analysis and exploitation, and counter-terrorism. He was awarded the British Empire Medal in 1976, following a tour of duty in West Berlin and the Queen's Gallantry Medal after a four year tour in Northern Ireland in 1984.

In his civilian career he has been a consultant advising "blue chip" clients in the City of London about the threat from environmental groups, a civil servant working in a special counter intelligence team at the Ministry of Defence HQ in Whitehall; a security manager for a US investment bank's offices in London and Europe and as "Head of Risk" for a specialist risk and security company in Ashford.

Mr. Kevin Green is a Secure Leadership Selector at Burril Green - Management Consultants for Corporate Security. He has specialized in the development of strategies to achieve new levels of growth, efficiency, and organization. As a practitioner within organizations, and as a third party advisor, he has acquired a rounded perspective on organizational needs and behaviour.

His experience drew him to working internationally from city bases like London, Amsterdam, New York, Paris, and Madrid, serving a diverse range of globally-operating blue-chip companies, which cluster into three groups. Firstly, the technology focused operators like Hewlett-Packard, Kodak, Philips, Xerox, and Unysis; secondly, the manufacturers from food and personal products like Colgate-Palmolive, Kraft General Foods Mars, Nestle, Procter & Gamble and Unilever to cars like Mercedes, Peugeot-Citroen and Volvo; and thirdly, service providers ranging from local government to utility corporate in gas, oil, and telecommunications.
