IMLI/WMU SYMPOSIUM ON FLAG STATE **RESPONSIBILITIES AND THE FUTURE OF ARTICLE 91** OF UNCLOS HELD AT IMO HEADQUARTERS

The IMO International Maritime Law Institute (IMLI), in collaboration with World Heidar (Judge, ITLOS), Mr. Ed Maritime University (WMU) organized on 5 March 2020 a Symposium on Flag State Watt (Addleshaw Goddard LLP) Responsibilities and the Future of Article 91 of the United Nations Convention on and Dr. Ian Hoffmann (Chief, Professor David Attard (Director, IMLI) the Law of the Sea (UNCLOS). The Symposium was held at the Headquarters of Trade Logistics Brand, Division delivering his remarks the International Maritime Organization (IMO) and was co-hosted by IMO and the of Technology and Logistics, International Tribunal for the Law of the Sea (ITLOS). The Symposium was attended UNCTAD) and deliberated on the development and interpretation of Article 91 of by representatives of IMO Member States, international organizations, maritime UNCLOS lawyers, and academics. IMLI alumni were also in attendance.

Mr. Kitack Lim (IMO Secretary-General) delivered the opening remarks. He noted that States, in their capacity as flag, port and coastal States have the obligation to comply with IMO rules and regulations. In this respect, it is important to enhance capacity-building for the successful implementation of the Organization's conventions and prescriptions so as to advance the IMO's role and contribute to the achievement of its goals. Mr. Lim observed that there was great value in exploring the relationship between UNCLOS and IMO conventions and that it was his hope that this Symposium will serve as the platform to advance further discussions on the matter.

In his remarks, Judge Jin-Hyun Paik (President, ITLOS), welcomed the opportunity to discuss the issue of flag State responsibilities and emphasized that "it is important for us to step outside the deliberation room in Hamburg and to engage with the shipping community and IMO delegates on areas of concern in relation to the nationality of vessels." He informed the participants that the Tribunal "wishe[d] to ensure that States Parties to the Convention, and flag States in particular, understand the work of the Tribunal and the possibilities it offers for dispute settlement in relation to disputes involving vessels."

Dr. Cleopatra Doumbia-Henry (President, WMU) addressed the Symposium and highlighted the importance of the topic to the academic curricula of both institutions and recognized the teaching of flag State obligations as a foundation area of studies. Upon briefly explaining the development of the "genuine

link" principle, Dr. Doumbia-Henry emphasized the importance of the subject as one which crosscuts in all activities in shipping.

Kenney (Director, Legal Affairs and External Relations Division, IMO), and Mr. Neville Aquilina (Chair, Sanctions Monitoring Board and Director General, Global Issues, International Development & Economic Affairs, Ministry for Foreign and European Affairs, Malta), speakers of the second panel which was moderated by Professor George Theocharidis (Professor, WMU), addressed current and future challenges on the implementation of Article 91 of UNCLOS by flag States.

The third panel was moderated by Ms. Gillian Grant (Vice-Chair, IMO Legal Committee and Alternate Permanent Representative of Canada to IMO) and included as speakers Mrs. Elizabeth Bouchard (Deputy Commissioner, Maritime Affairs, Marshall Islands), Mr. Kostas Ladas (General Manager, Liberia International Ship and Corporate Registry (LISCR), London), Ms. Naomi Burke O'Sullivan (Legal Officer, ITLOS) and Professor George Theocharidis (Professor, WMU). The discussions of the panel focused on the modern ship registry and implementation of IMO instruments as well as future work.

The closing remarks were delivered by Mr. Kenney who expressed his appreciation to all the speakers and participants for their valuable contributions.

The Assembly of the International Maritime Organization (IMO) adopted on 4 December 2019, during its thirty-first session, Resolution A.1147(31), entitled "Preserving the Legacy of the World Maritime Day Theme for 2019 and Achieving a Barrier-Free Working Environment for Women". The Resolution (attached for ease of reference) originated from a joint initiative of Malta and Ghana with the contributions of Dr. Michaela Muscat (Maritime Attaché, Permanent Mission of Malta to IMO) and the IMLI Alumna, Mrs. Azara Al-Hassan Prempeh (Alternate Permanent Representative of Ghana to IMO). Canada and Georgia co-sponsored the Resolution.

The Resolution reaffirms the "commitment made in the 2030 Agenda for Sustainable Development Goals, especially Goal 5 'Gender Equality', which aims to achieve gender equality and empower all women and girls." The Resolution also resonates with IMO's strategic framework and its "central role in enhancing progress towards gender integration within the maritime sector, through its [the Organization's] Women Maritime Programme,"

The Resolution recognizes that "[...] as far back as 1988, the Organization was in the vanguard of United Nations specialized agencies, as it put in place an institutional framework to incorporate a gender dimension into the Organization's policies and procedures, including a 50% quota for women for one of its educational institutes, through the adoption of resolutions aimed at ensuring access to maritime training and employment opportunities for women in the maritime sector."

MINISTER FOR SUSTAINABLE DEVELOPMENT **VISITS IMLI**

Minister Abela acknowledged the leading role of IMLI in the area of international maritime law and expressed his pleasure in meeting the students of this year. He explained that Malta has always had a strong interest in protecting the oceans and has promoted international legislation for their sustainable governance. Minister Abela also referred to the interest generated by many countries on the blue economy which shall ensure a sustainable use of ocean resources for economic growth, improved living and employment while safeguarding the fragile marine ecosystems. In his view, sustainable development calls for governments to work together to preserve the oceans for our future generations.

THE UNITED NATIONS GENERAL ASSEMBLY EXPESSES APPRECIATION FOR THE WORK OF IMLI

The United Nations General Assembly adopted on 10 December 2019, during its seventy-fourth session, Resolution A/RES/74/19 entitled "Oceans and the law of the sea". The Resolution, which was adopted by 135 votes in favor, tackles the main aspects of the 1982 United Nations Convention on the Law of the Sea (UNCLOS), and calls upon States that have not done so to become parties to the Agreement for the Implementation of the Provisions of UNCLOS, to harmonize national legislation

with the Convention, and for capacity-building initiatives to consider the needs of developing countries.

The General Assembly, through this Resolution, acknowledged for the twelfth consecutive year the contribution of the IMO International Maritime Law Institute (IMLI) to the international community. In paragraph 30 of this Resolution the UN's highest representative body recognizes:

"[...] the importance of the work of the Malta-based International Maritime Law Institute of the International Maritime Organization, as a centre of education and training of specialists in maritime law, including government legal advisers and other high-level officials, mainly from developing States, confirms its effective capacitybuilding role in the field of international maritime law, shipping law and maritime environmental law, and urges States, intergovernmental organizations and financial institutions to make voluntary financial contributions to the budget of the Institute which runs annually."

IMO ASSISTANT SECRETARY-GENERAL LECTURES AT IMLI

Mr. Lawrence Dehniah Barchue Sr. (Assistant Secretary-General / Director, Department for Member State Audit and Implementation Support, International Maritime Organization (IMO)) delivered a lecture to the IMLI Class of 2019-2020 on 'Development of a Compliance Monitoring Mechanism - The IMO Member State Audit Scheme (IMSAS)'.

Mr. Barchue started his lecture by providing a brief historical background of the compliance monitoring mechanism. He then addressed the institutionalization of the audit scheme, relevant IMO resolutions and expected benefits of the mandatory audit scheme by using analogies to aviation and the International Civil Aviation Organization (ICAO). Mr. Barchue also covered the evolution of IMSAS. In this regard, he explained the Voluntary IMO Member State Audit Scheme (VIMSAS) and the chronological development of IMSAS.

While addressing the students, Mr. Barchue highlighted the role of IMO Member States, shipping industry, seafarers and recognized organizations, being the main actors in the shipping industry, in ensuring compliance with the international maritime standards. He also mentioned the IMO Instruments Implementation Code (III Code) which serves as the audit standard under the IMSAS.

Mr. Barchue emphasized that the ultimate effectiveness of any IMO instrument depends upon the Member States acting in their capacity as port, flag and coastal States. Hence, it is their primary responsibility to have in place an adequate and effective system to exercise control over ships, and to ensure that they comply with relevant international rules and regulations in respect of maritime safety, security and protection of the marine environment. In this regard, Mr. Barchue encouraged the IMLI students, upon their graduation, to assist their respective countries in meeting their responsibilities and discharging their obligations under the conventions and other instruments to which they are party, in particular with respect to the enactment of relevant laws and regulations.

At the end of his lecture, Mr. Barchue placed the IMLI badge on the map to record the representation of São Tome and Principe for the first time in any of IMLI's programmes. The participation of Ms. Josenelcia Da Conceição Bandeira (student from São Tome and Principe) was made possible thanks to the generous funds of the IMO Technical Division.
