## **IMLI COMMENCES ITS 32ND ACADEMIC YEAR**

On Monday, 12 October 2020, the IMO International Maritime Law Institute (IMLI) welcomed its 32nd generation students for the academic year 2020-2021. The welcoming address was delivered by Mr. Kitack Lim (IMO Secretary-General, IMO and Chairman of the IMLI Governing Board).

Mr. Lim expressed his pleasure in addressing the students on this day which marks the beginning of a new chapter in their professional development. Mr. Lim informed the students that by joining a prestigious educational institution of whose role in maritime training the IMO and the entire international maritime community is very proud, they are already part of the greater IMO family. He referred to the students as ".. valuable assets and real treasures to the maritime world" who through their education at IMLI will facilitate mutual and harmonious understanding between their countries in their respective engagements. Mr. Lim urged the students "to support each other in this journey and maintain your global outlook through

thinking and communication". Mr. Lim concluded his message by wishing the students every success in their studies and the very best for the future.

When addressing the new students, Professor Attard (Director, IMLI) said that it was an honour and privilege to welcome such a diverse class from all over the world to IMLI's 32nd academic year. He informed the students that IMLI was set up to train maritime lawyers, especially from developing countries, on the whole spectrum of international maritime law and how to incorporate and effectively implement IMO treaties and guidelines into domestic legislation. Professor Attard noted that IMLI's uniqueness is reflected, among other things, in its comprehensive syllabus which considers maritime law from an international perspective.

Professor Attard reassured the students that the Institute is building on the success of the virtual learning of the last academic year and hopes that this year will be as successful, especially in the light of the Institute's commitment to continue providing, with its usual excellence, the training it has always offered in capacitating expertise in international maritime law.
