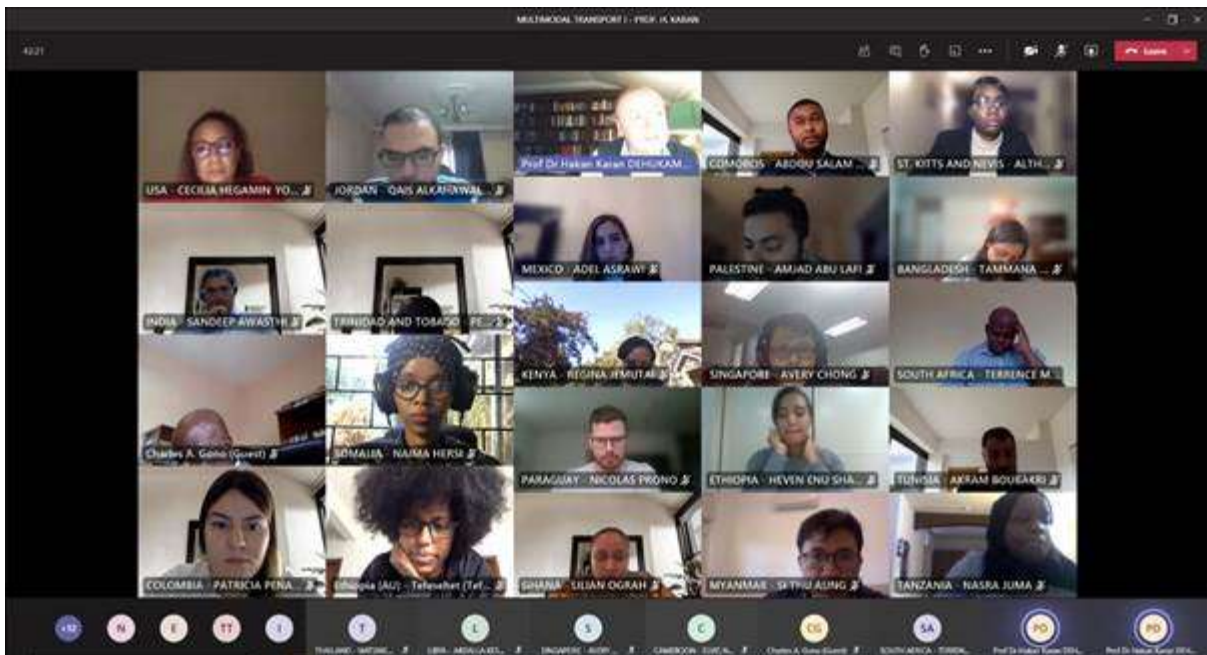




DIRECTOR THE RESEARCH CENTRE OF THE SEA AND MARITIME LAW (DEHUKAM) ANKARA UNIVERSITY LECTURES AT IMLI

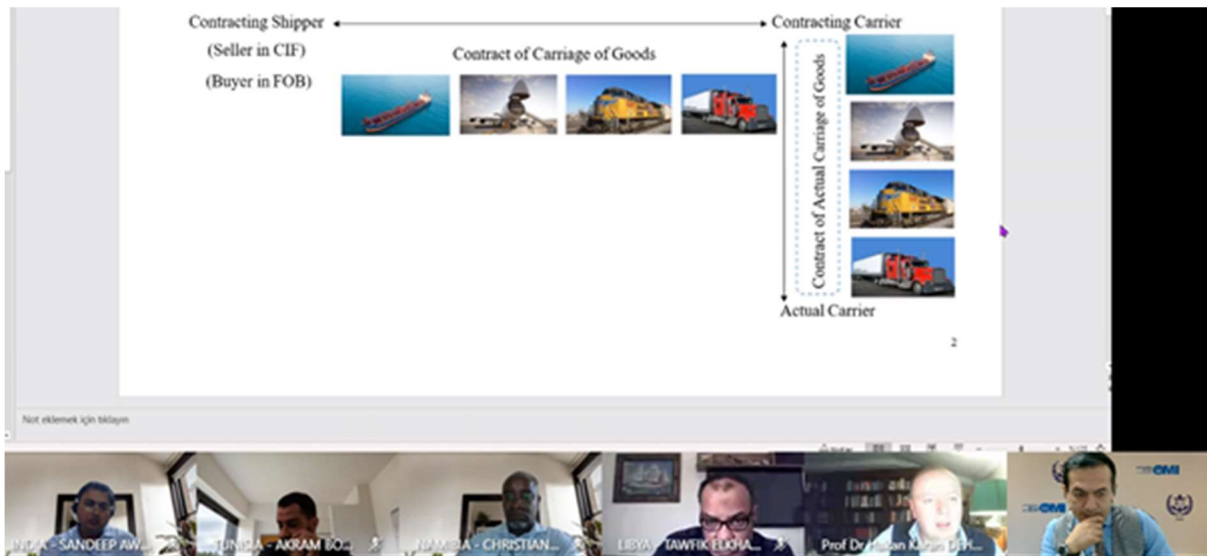
Professor Hakan Karan (Director, National Centre for the Sea and Maritime Law -DEHUKAM, Ankara University) delivered a number of lectures within the Institute’s course on Carriage of Goods by Sea. His lectures included “*International Rules of Carriage of Goods by Sea*”, “*Multimodal Transport*” and “*The Transport Documents at Sea*”.

Professor Karan introduced his lectures by discussing international trade and sale of goods. He then went on to discuss the contract for the international carriage of goods by sea within the coverage of the convention-based rules in force such as the Hague Rules, the Hague-Visby Rules, the Hamburg Rules, and the Rotterdam Rules. Professor Karan’s lectures on international carriage of goods by sea also included jurisdictional aspects in disputes arising

from such carriage, the applicable law of the contract, the contract and contracting parties, contractual obligations, and liabilities.



Professor Karan also gave the students an in-depth explanation of the concept of multimodal transportation with practical examples of multimodal transportation. He also defined the term “Maritime Transport document” as a document issued under a contract of carriage by the carrier that evidences the carrier’s receipt of goods under a contract of carriage as well as the conclusion and contents of a contract of carriage by sea. This was followed by a detailed discussion of the subject area.

Professor Karan’s lectures provided the students with the opportunity to gain a holistic knowledge on the subjects taught within area of the carriage of goods by sea.

Professor Hakan Karan, LL.M., Ph.D. in law, Attorney-at-Law, is Professor at the Law Faculty of Ankara University and Legal Adviser to the Turkish Ministry of Foreign Affairs, Department of Maritime and Civil Aviation Affairs, Ankara, Turkey. He is a Member of the Research Institute of Banking and Commercial Law in Ankara as well as the ICC Commission on Transport and Logistics. He has been Chief Editor of the Banking and Commercial Law Journal (BATIDER), the Research Institute of the Banking and Commercial Law, in Ankara, Turkey, the Journal of Law Faculty of Inonu University, Malatya, in Turkey and the DEHUKAM’s Sea, Maritime Law Journal (DEHUKAMDER), and the Research Centre of the Sea and Maritime Law, Ankara, in Turkey.

He regularly attends the meetings of the IMO Legal Committee as a Turkish delegate. He writes and teaches in the field of Maritime Law including the International Law of the Sea. Professor Karan has been a Visiting Professor in numerous universities including, Rhodes Academy of Oceans Law and Policy, Rhodes, Greece (Summer School), Galatasaray University, Law Faculty, Istanbul, Turkey (Post-Graduate), and Bilkent University, Law Faculty, Ankara, Turkey (Undergraduate).
