SECOND ANNUAL COURSE ON THE LAW OF PORTS TO COMMENCE AT IMLI

The IMO International Maritime Law Institute (IMLI) would like to inform its readers that the Institute will commence on 1 February 2021 the second annual course on Law of Ports. Part A, which is “Introduction to the Law of Ports” will commence in February 2021 and conclude in March 2021. Part B which consists of “Specialist Seminars on the Law of Ports” will commence in March and end in April 2021.



The Second Annual Course on the Law of Ports will emphasize the importance of the work of the IMO for the efficient management of ports and the effective implementation by States of their obligations acquired under international treaties. It will also address many aspects of port

operations, as well as numerous areas covered by IMO conventions and prescriptions which are of

vital importance to the Law of Ports, particularly to enhance security, safety, environmental protection, and facilitation.

The Course will also emphasize the role of ports in the development of infrastructure which is vital to the economic growth of developing countries, especially Small Island Developing States.

In the light of its comprehensive coverage, this Course will be of immense benefit to professionals involved in the maritime industry, such as lawyers, maritime practitioners, port officers, and ship operators. The Course would also be of interest to law students who wish to pursue a career in the field.

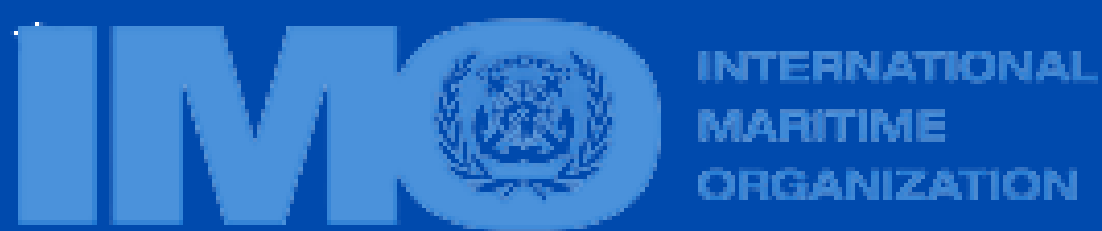
At the end of the course, a certificate of participation will be issued.

PROGRAMME

It has been recognized that more than 80 per cent of goods sold in international trade are carried by sea. Ports have been, in fact, centres of commerce since time immemorial and, with the progressive transformation of international trade due to the globalization of economy, shipping has been confirmed as the most efficient means of transport in terms of volume.

The fact that coastal States enjoy territorial sovereignty over their ports, has often led to the belief that ports fall exclusively within the realm of national law irrespective of any developments in international maritime law, especially the IMO regulatory framework. The reality of ports operations and States' measures to ensure that ports are efficient, safe, secure, and environmentally friendly, has however contrasted such misconception. Considered as the gateways of the world to international trade and a supportive structure for economic activities and development, ports are now subject to extensive regulations which reflect numerous IMO treaty provisions.

The Second Annual Course on the Law of Ports emphasizes the importance of the work of the IMO for the efficient management of ports and the effective implementation by States of their obligations acquired under international treaties. The Second Annual Course will address many aspects of port operations, as well as numerous areas covered by IMO conventions and prescriptions which are of vital importance to the Law of Ports, inter alia, security, safety, environmental protection, and facilitation.

The Second Annual Course overviews the IMO regulatory regime on the protection of the marine environment which extends to ports. It explains that ships, which may not be compliant with the requirements of international treaties and prescriptions promulgated to protect the environment from ship-source pollution (accidental or operational) may not be allowed to proceed to sea. This also extends to ships' contingency plans in case of pollution incidents and to those relating to the maintenance of compulsory insurance to compensate victims of pollution incidents. Discussions focus on the port States legislative and enforcement powers which reflect the provisions of UNCLOS and of the IMO Conventions.



Further, the Second Annual Course highlights the leading role of IMO in regulating prevention of air pollution from ships. To realize IMO's goal of decarbonization and desulphurization, ports have a critical role to play. From the compliant fuels they supply, to inspections to ensure the implementation of the adopted regulatory regime, port States are catalyst in the process.

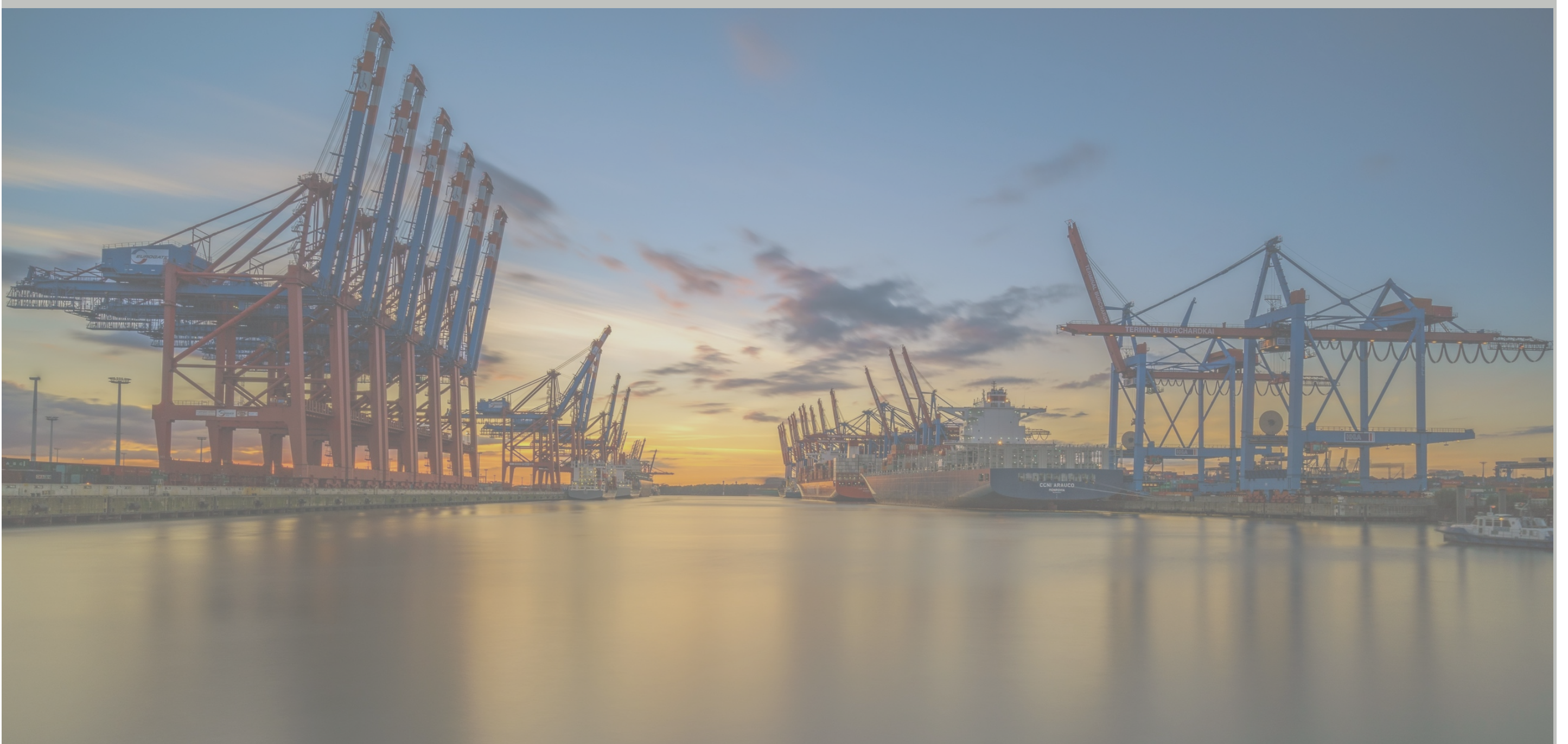
Whereas ports, thanks to the infrastructural developments and advancements in technology, have witnessed a tremendous transformation and are the nexus that connects maritime transport with land transportation, they are also facing several security risks. The pursuit of efficiency and competitiveness shall be balanced with adequate security measures, especially those developed by the ISPS Code. For this purpose, the Second Annual Course will address the IMO responses to security threats in ports.

It should be recalled that IMO has noted that for international shipping to thrive, a unified, global approach to facilitation is vital. This has led to the adoption for the FAL Convention

which sets uniform standards and recommended practices and rules for simplifying formalities, documentary requirements and procedures on ships' arrival, stay and departure. As the FAL Convention continues to be revised and amended to meet the needs of international trade, the Course reviews the latest developments in the field which require understanding and application by port authorities.

Port authorities play a vital role in the upholding of labour standards. As explained in the Course, the effective implementation of regulations on repatriation, crew change arrangements, and compliance and enforcement, as stipulated in the Maritime Labour Convention, depends as much on port States.

Under the current COVID-19 pandemic, the Course also highlights the importance of uninterrupted flow of the global supply chain as well as the need for robust measures to ensure the repatriation and travel arrangements of seafarers and passengers while respecting the health and safety restrictions imposed by port States.
