THE IMO SECRETARY-GENERAL DELIVERS THE 31ST GRADUATION ADDRESS

In his address, Secretary-General Lim stated that he was delighted to deliver his message for the Institute's first ever virtual graduation ceremony to celebrate the success of the Class of 2020. Mr. Lim noted that the outbreak of the COVID-19 pandemic has had an unprecedented effect on the shipping industry and on seafarers themselves. He observed that the Institute also faced challenges which prompted it to take unprecedented measures to ensure the health and safety of its students and successful completion of the academic year. He congratulated the graduands for their remarkable achievement and invited them to apply the newly acquired knowledge and skills for the benefit of their countries and international maritime community.

The Graduation Address of the Secretary-General is reproduced below:

Dear Graduands,

It is a great pleasure for me to address you on this very prestigious occasion. The outbreak of the COVID-19 pandemic had an unprecedented impact on the shipping industry and on seafarers themselves. The Institute itself has also been faced with the challenges and needed to take unprecedented measures to ensure health and safety of its students and successful completion of another academic year.

Indeed, I am very delighted to deliver this message for the Institute's first ever virtual graduation ceremony to celebrate the success of the Class of 2020. You, the graduands, are therefore taking part in another milestone for the Institute.

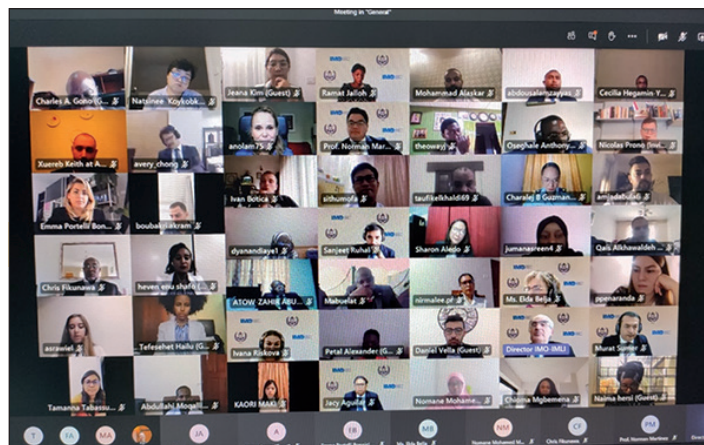


Mr. Kitack Lim (IMO Secretary-General, IMO and Chairman of the IMLI Governing Board) delivering the Welcoming Address

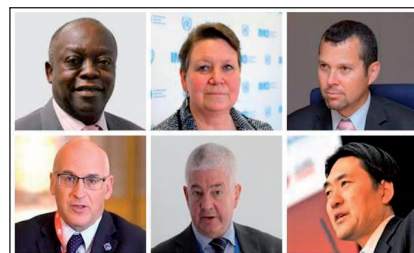


National Flags of the Countries represented at IMLI for the academic year 2020-2021

RECOGNITION OF IMLI'S MASTER OF LAWS DEGREE AND DOCTOR OF PHILOSOPHY BY THE MALTA NATIONAL COMMISSION FOR FURTHER AND HIGHER EDUCATION

The Institute wishes to announce that the Malta National Commission for Further and Higher Education (NCFHE) has recognized the Institute's Master of Laws Degree and Doctor of Philosophy (Ph.D.) Degree.

IMLI appreciates the efforts of the Government of Malta, and in particular the NCFHE and its accreditation division, to implement the decision of the 2019 IMO Assembly urging governments to recognize the degrees conferred by the Institute.

With reference to the Master's Degree, Mr. Lawrence Azzopardi (Head of Accreditation of the NCFHE) observed that, since IMLI is an international institution, it does not fall within the remit of the NCFHE. However, after an evaluation carried out by independent academic experts, *"the NCFHE recognises that the Master's degree conferred by IMLI has reached the standards of a Master's Degree at MQF Level 7 pursuant to the Subsidiary Legislation 327.433 Further and Higher Education (Licensing, Accreditation and Quality Assurance) Regulations."*

IMLI GOVERNING BOARD HOLDS ITS 34TH SESSION

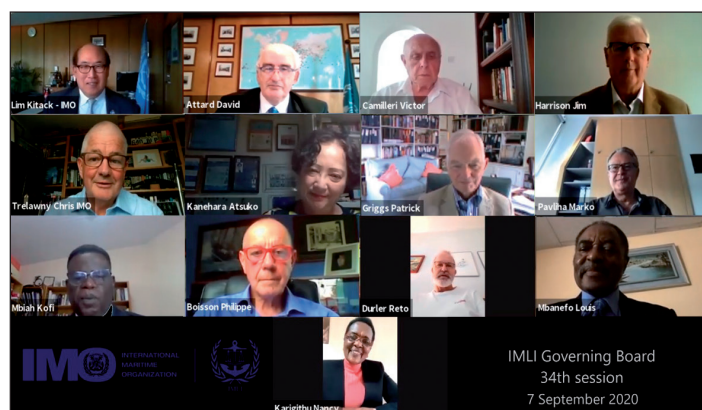
The 34th session of the IMLI Governing Board (the Board) was held virtually on 7 September 2020. The session was attended by Mr. Kitack Lim (Chairman), Mr. Chris Trelawny, Professor David Attard, Mr. Victor Camilleri, Dr. Philippe Boisson, Dr. Reto Dürler, Dr. Patrick Griggs, Mr. Jim Harrison, Professor Atsuko Kanehara, Ms. Nancy Karigithu, Mr. Louis N. 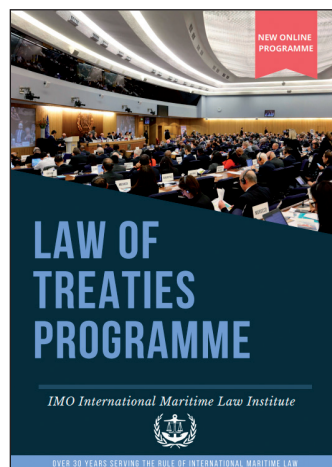

NEW LAW OF TREATIES PROGRAMME OFFERED AT IMLI

To promote capacity-building in the Law of Treaties, IMLI, in cooperation with Queen Mary University of London, is offering an intensive programme on the subject. The first part of the Programme is a comprehensive course on Introduction to the Law of Treaties, covering the major aspects of the Law of Treaties. This part of the



Programme also prepares the ground for a better understanding of the second part of the Programme which consists of Specialist Seminars on the Law of Treaties, co-ordinated by academics from Queen Mary University of London.

This Programme is addressed to all who need to understand the intricacies of the Law of Treaties and the rights and obligations of States Parties under the same. For these reasons, the Programme would be most suitable to representative of States to international organizations, foreign relations experts, legal officers of maritime administrations, and maritime consultants. The Programme would also prove beneficial to law students who wish to pursue a career in the field.
