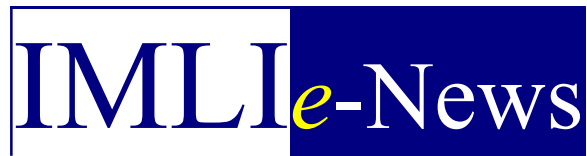

# SYNOPSIS

*Labour at sea is deemed unique owing to its specific features and the environment in which it takes place. Seafarers, by the nature of their employment, are an isolated international occupational group of workers who face prolonged absence from their homes, resulting in important social and legal consequences. Unfortunately, since the development of the maritime industry, seafarers' fundamental rights have not always been considered a priority, thereby often not respected by shipowners.*

*Therefore, it was deemed necessary to adopt international rules to make special provisions for seafarers' rights protection and to ensure effective implementation of their provisions through the cooperation of the international community. The latest of these efforts is the Maritime Labour Convention 2006 (MLC), as amended. The Convention aims to ensure comprehensive worldwide protection of the rights of seafarers and establish a level playing field for countries and shipowners committed to providing decent working and living conditions for seafarers, protecting them from unfair competition on the part of substandard ships.*

*In addition to the already precarious situation of seafarers, the COVID-19 pandemic has put this group of persons in a more perilous condition. Travel restrictions mean that some seafarers cannot leave their ships, be repatriated home, or even get urgent medical assistance. Other seafarers have seen their contracts unilaterally terminated or have been quarantined on board ships for more than 14 days, without getting paid.*

*As of December 2020, an estimate of 400,000 seafarers are currently stranded on ships beyond the end of their original contracts and unable to be repatriated, due to COVID-19 related travel restrictions. A similar number of seafarers are stuck at home, unable to join ships and provide for their families.*

*In this regard, the IMO established the Seafarer Crisis Action Team (SCAT) to help resolve individual cases, often working alongside other organizations like the ILO, the ITF and the ICS. This crew change crisis and the importance of the work of seafarers has heightened to the extent that IMO's World Maritime Theme 2021 will be "Seafarers: at the core of shipping's future".*

*IMLI has been in the vanguard in raising awareness on the importance of maritime labour law standards. Indeed, the IMLI Course on Seafarers' Rights reiterates the Institute's commitment to the protection of seafarers in line with the international efforts spearheaded by the IMO and ILO.*
