

The book was edited and co-authored by Professor Marko Pavliha (Professor of International Maritime Law, Transport Law, and Insurance Law at the University of Ljubljana, Faculty of Maritime Studies and Transportation, Portorož, Slovenia). Professor Pavliha is also a longstanding Visiting Professor at IMLI and a Member of the IMLI Governing Board.

Professor Attard expressed in the Foreword to the Book his pleasure at being invited to write the same, noting that Professor Marko Pavliha's initiative to produce this Book is both timely and necessary and that he should be congratulated for inviting such eminent scholars to contribute learned articles on the different perspectives of passenger carriage. He noted further that the topic of transport law on passenger rights, particularly in respect of carriage by sea and the relevant work of IMO, has been a major focus of his work for several years in his capacity as Director of IMLI. Professor Attard also observed that the academic syllabus at IMLI covers extensively the interrelationship that carriage by sea has with other means of transport.

## He concluded by stating that:

"Professor Pavliha and his collaborators have produced a rich study on transport law and its human dimension reflected particularly in the protection of passenger rights. This book represents an important contribution to the scholarly literature on the subject. Furthermore, its inclusion of extensive state and regional practice ensures its importance to practitioners and academics alike. It is therefore with great pleasure that I commend the efforts of all contributors (some of them actively involved in IMLI teaching) in producing this magnificent work."

The book series "IMLI Studies in International Maritime Law" published by Routledge simultaneously in London and New York, is dedicated to the publishing of original, scholarly contributions that analyze key issues in international maritime law, which are of interest to an audience of students, scholars and practitioners in international maritime law. In January 2019, Professor Norman Martinez succeeded Professor David Attard as General Editor of the book series.
