
The Institute had the pleasure of welcoming eminent Judges from the International Tribunal for the Law of the Seas (ITLOS) between 2 and 6 May who addressed the participants in the IMLI Course on the Peaceful Settlement of Maritime Disputes and Delimitation of Maritime Boundaries. The Course which was inaugurated by the Judge Albert Hoffmann (President, ITLOS) was addressed by Judge Markiyan Kulyk, Judge Liesbeth Lijnzaad, and Judge Jin-Hyun Paik. These eminent personalities were introduced by Judge Professor David Attard (Director, IMLI).







Judge Markiyan Kulyk (Judge ITLOS) delivered on 3 May a lecture titled "Advisory Proceedings under UNCLOS." Professor Attard, during his introduction, informed the participants that Judge Kulyk has served as a Judge for over 10 years. Professor Attard also recalled that Judge Kulyk has been a Visiting Lecturer at IMLI for a number of years.




Judge Liesbeth Lijnzaad (Judge, ITLOS), delivered a lecture entitled "Provisional Measures." In welcoming Judge Lijnzaad, Professor David Attard told the participants that she is an eminent international lawyer, who prior to becoming a Judge at ITLOS, combined a very distinguished diplomatic and academic career.

Judge Jin-Hyun Paik who delivered a entitled lecture "Seabed Dispute Chambers" has been a Member of the Tribunal since 2009. Judge Paik was President of the Tribunal between 2017-2020. He was a Member of the Special Chamber formed to deal with the dispute concerning the delimitation of the maritime boundary between Ghana and Côte d'Ivoire in the Atlantic Ocean. boundary between Mauritius and Maldives in the Indian Ocean (Mauritius/Maldives).

SENIOR LEGAL COUNSEL AT THE PERMANENT COURT OF ARBITRATION LECTURES AT IMLI

Also within the IMLI Course on the Peaceful Settlement of Maritime Disputes and Delimitation of Maritime Boundaries, Mr. Garth Schofield (Senior Legal Counsel at the Permanent Court of Arbitration (PCA)) delivered a lecture entitled "*Annex VII Arbitration*". Mr. Schofield was introduced by Professor David Attard (Director, IMLI) who informed the participants that Mr. Schofield has administered numerous arbitrations and works closely with arbitral tribunals constituted in some of the PCA's largest and most complicated proceedings, including maritime boundary disputes under Annex VII of the UN Convention on the Law of the Sea. Professor Attard noted further that in the majority of these cases, Mr. Schofield acts as Registrar or Secretary to the Tribunal.


MEMBER OF THE FACULTY OF LAWS AT THE UNIVERSITY OF MALTA LECTURES AT IMLI

He informed the participants that Dr. Attard has for a number of years specialised in international law including the law of the sea, maritime security law, migration law, human rights law and refugee rights law. He noted also that Dr. Attard is an alumna of the Institute and the author of the monograph "The Duty of the Shipmaster to Render Assistance at Sea under International Law" published by Brill in its Queen Mary Studies.
