





PROFESSOR MARKO PAVLIHA ADDRESSES THE FIFTH ADRIATIC MARITIME CONFERENCE

During the Fifth Adriatic Maritime Conference held in Croatia between 26 and 28 May, Professor Marko Pavliha (Member of the IMLI Governing Board and Professor of Commercial, Transport and Insurance Law at the University of Ljubljana, Faculty of Maritime Studies and Transportation, Slovenia) delivered a presentation on the "New IMLI Study: Transport Law on Passenger Rights". The book was edited and co-authored by Professor Pavliha. Contributors to the book include Professor David Attard and Professor Norman Martinez. The book has been published under the book series "IMLI Studies in International Maritime Law" by Routledge simultaneously in London and New York.







PROFESSOR NORMAN MARTINEZ ADDRESSES THE FIFTH ADRIATIC MARITIME CONFERENCE

Professor Norman Martinez (Professor, IMLI) delivered a presentation to the Fifth Adriatic Maritime Conference on "Maritime Transport of Passengers: Liability Regime". In his engaging presentation, Professor Martinez discussed the current international and European regulatory framework and the interplay between them. Professor Martinez argued that, despite the apparent advantages brought up by the international and EU instruments, large areas of passenger law and law relevant to the cruise industry remain to be covered by national consumer laws, hence, States are encouraged to embed the principles discussed in the presentation into their national framework regulating sea passengers' rights.
