Professor Ignacio Arroyo Martínez (former President of the Spanish Maritime Law Association)


The Universitat Jaume I in Spain has awarded a Doctorate *Honoris Causa* to Professor Ignacio Arroyo Martínez (former President of the Spanish Maritime Law Association), for his renowned prestige in lecturing and researching on maritime law and his extensive scientific work, making him an obligatory reference for study in this field of knowledge. Referred to by the Spanish maritime community as the "Father of Modern Spanish Maritime Law", he is the founder and general editor of the Spanish Yearbook of Maritime Law (Anuario de Derecho Marítimo), the first Spanish maritime journal covering all the aspects of public and private maritime law.
