IMLI HOSTS AN INTERNATIONAL SEMINAR ON THE IMPORTANCE OF THE LAW OF THE SEA IN THE 21ST CENTURY AND THE PROSPECT FOR THE FUTURE

IMLI held on 27 March 2023 an International Seminar on "The Importance of the Law of the Sea in the 21st Century and the Prospect for the Future". The Seminar highlighted that the Convention is a living instrument which accommodates developments, and its adequate implementation facilitates a sound governance for the oceans. It was addressed by eminent speakers who have dedicated their professional life to international law and law of the sea matters.

What added value would an Advisory Opinion on Climate Change have?"

The second presentation was delivered by Professor Alessio Patalano (Professor, King's College London) entitled "Unmanned systems and the law of the sea: What is the legal-security nexus?"

Professor Patalanos' presentation was followed by the presentation of Professor Hikmahanto Juwana (Professor of Law, University of Indonesia) on "The Implementing the Challenges in UN Convention on the Law of the Sea: Some Experiences from Indonesia".


