ANNUAL MARITIME TRANSPORT POLICY SEMINAR HELD AT IMLI

For the eighth consecutive year, IMLI had the distinct pleasure of holding, in collaboration with IMO and World Maritime University (WMU), the annual three-day Seminar on Maritime Transport Policy. This year, the Seminar was conducted by Professor George Theocharidis (Professor of Maritime Law & Policy, WMU). Professor Theocharidis was welcomed by Ms. Elda Kazara-Belja (Senior Lecturer/Head of Administration, IMLI) and the IMLI Faculty Members, after which he was introduced to the IMLI Class of 2023-2024.

During this three-day Seminar, the students were introduced to the concept of a Maritime Transport Policy and its importance to the development of maritime legislation by highlighting the close relationship between policy and legislation. At the end of the Seminar, as is usual practice, the Class, which had already been divided into groups, presented an outline of a National Maritime Transport Policy of an imaginary country. In doing so, each of the working groups had to take into account the obligations of the represented country under international maritime conventions and the socio-economic development strategies.



These countries, whose rich biodiversity hotspots are vulnerable coastal to biofouling, are also intrinsically linked to the global concern of climate mitigation/climate change, notably greenhouse the (GHG) emissions through gas attributed to maritime transport.
