# IMLI DIRECTOR REPORTS TO THE 130TH SESSION OF THE IMO COUNCIL

The 130th Session of the IMO Council was held between 21 and 24 November 2023 at the IMO Headquarters in London. During the Session, Professor Dr. Norman A. Martínez Gutiérrez (Director, IMLI) reported on the Institute's activities for the year 2022.

The Director provided the Council with documents detailing IMLI's operations for the year 2022, including information on the Institute's key governance arrangements, finances, programmes, students and staff, publications and projects, donors and IMLI's contribution to the UN 2030 Sustainable Development Agenda.

The Director was pleased to inform the Council that IMLI facilitates a hybrid learning environment which enables hundreds of professionals from around the world to participate online in its specialized courses. With great pride, the Director reported that IMLI's training continues to be sought after by many governments and professionals. By the end of the academic year 2021-2022, he reported that 985 students from 150 states and territories had graduated from the Institute's programmes.

The Director further recorded that IMLI's policy to reserve 50% of its places to deserving female candidates continues to be successful as evidenced by the large female participation in the year 2022-2023 which represented approximately 53% of the student body. The quality of the IMLI training is also now recognized by the relevant authorities in Malta. The Malta Further and Higher Education Authority (MFHEA) has recognized the IMLI degrees in its various programmes as meeting the relevant academic educational standards required by Malta. The Director expressed his hope that this initiative taken by the Government of Malta would be followed by governments of other countries.

With respect to cooperation, the Director in his report highlighted the close links with IMLI's sister institute, World Maritime University (WMU), as well as many other academic institutions, international organizations, and national agencies with which IMLI collaborates to deliver various training initiatives.

He then proceeded to thank the Government of Malta for its continuing support in providing the Institute's premises and for upgrading the facilities throughout the years, especially the recent refurbishment of the Institute's lecture hall with state-of-the-art equipment. Professor Martínez expressed sincere appreciation to all the Institute's donors, who, through their financial and fellowship donations make it possible for IMLI to continue its important capacity building work. He stated that IMLI continues to maintain its status as a renowned center of training and education in international maritime law. He restated that IMLI remains committed to training the maritime leaders of tomorrow by rendering a valuable service to

through the IMO member states training initiatives. These numerous efforts are critical, the Director noted, to the implementation of the support objectives of IMO, which is to establish a global maritime legal order.



In his second intervention of the day, the Director reported to the Council on the Institute's Budget for 2023 together with a proposal for 2024. In terms of financial matters, he was pleased to report that the institute remained firmly on its path of stable financial progress to support its academic goals and capacity building responsibilities. He reiterated his sincere appreciation to all the Institute's donors who contribute to the financial stability of the institute and allow IMLI to continue to flourish as a successful educational Institute.

In his conclusion, the Director stated that IMLI remains resolute in serving IMO and the international maritime community. He also appealed to the delegations present to support IMLI to continue to grow stronger in its capacity building mission.


