

1. Terminology

- 'Port' (Latin/Old English: haven, harbour) and 'harbour' (Germanic/old English: connotation of shelter, haven, refuge).
- "The term 'harbor' or 'port' means any place to which ships may resort for shelter or to load or unload passengers or goods, or to obtain fuel, water, or supplies. This term shall apply to such places whether proclaimed public or not and whether natural or artificial" (47 USC § 153(23)).
- "All ports which are normally frequented by sea-going vessels and used for foreign trade shall be deemed to be maritime ports within the meaning of the present statute"(1923 Convention).
- Ports run by Port Authorities, public ports, small craft harbours (fishing, recreational vessels) (e.g., Canada).
- Port State: the State within whose port or offshore terminal a vessel has entered voluntarily (UNCLOS art 218).
