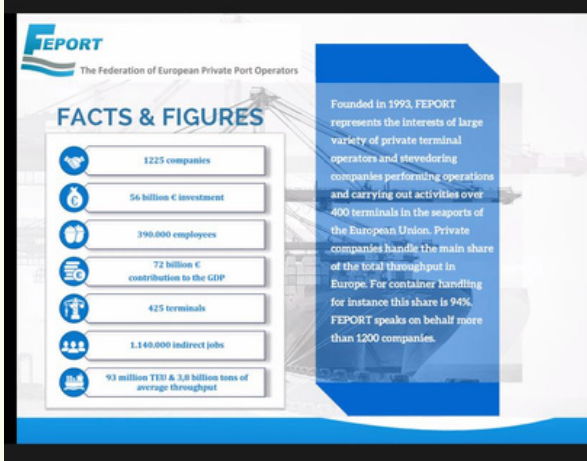

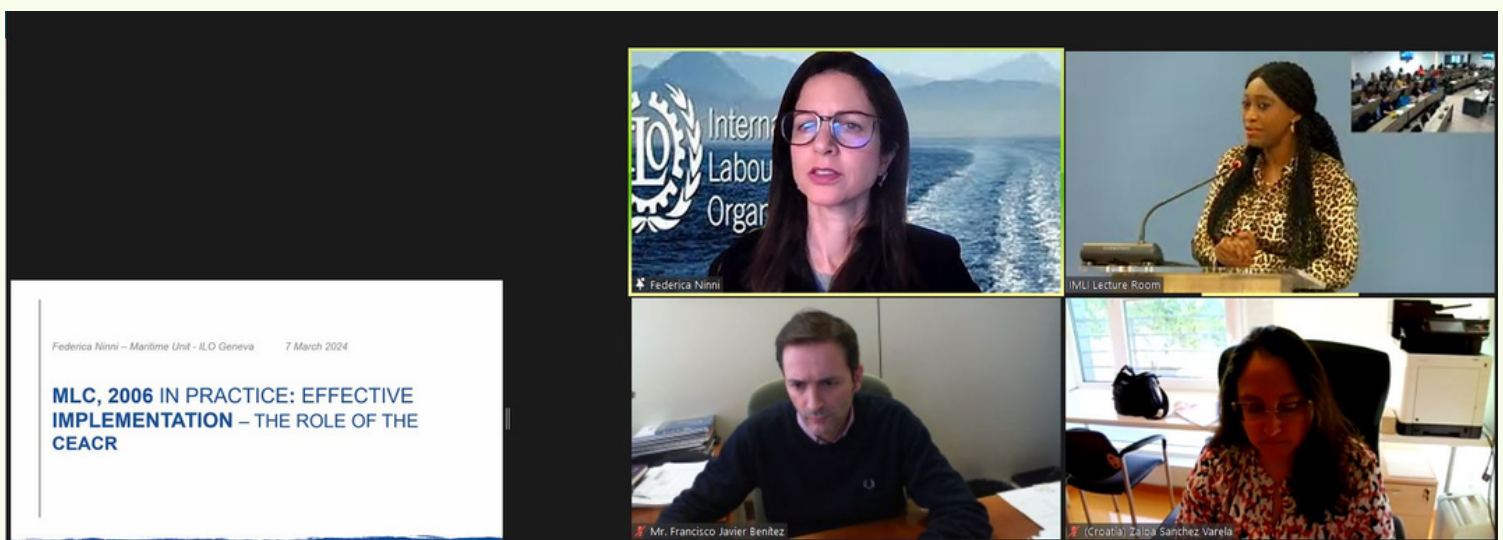
## LAWYER WITHIN THE MARITIME UNIT OF THE INTERNATIONAL LABOUR ORGANIZATION LECTURES AT IMLI

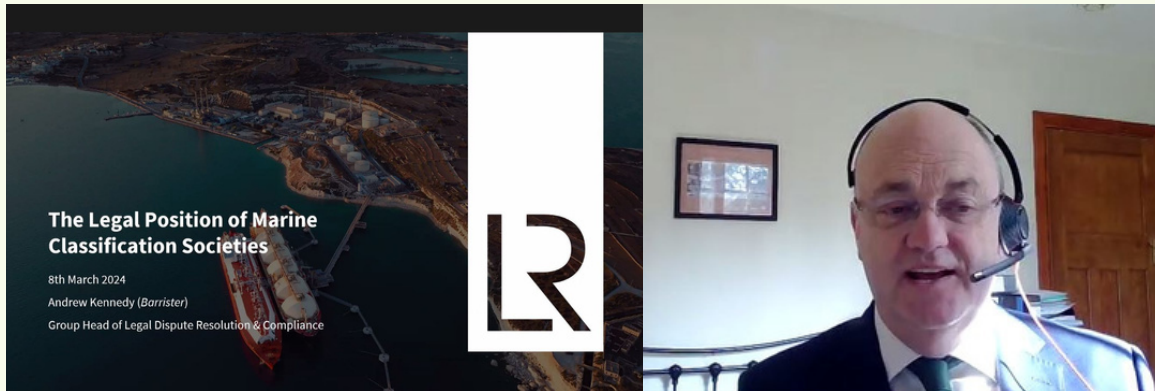

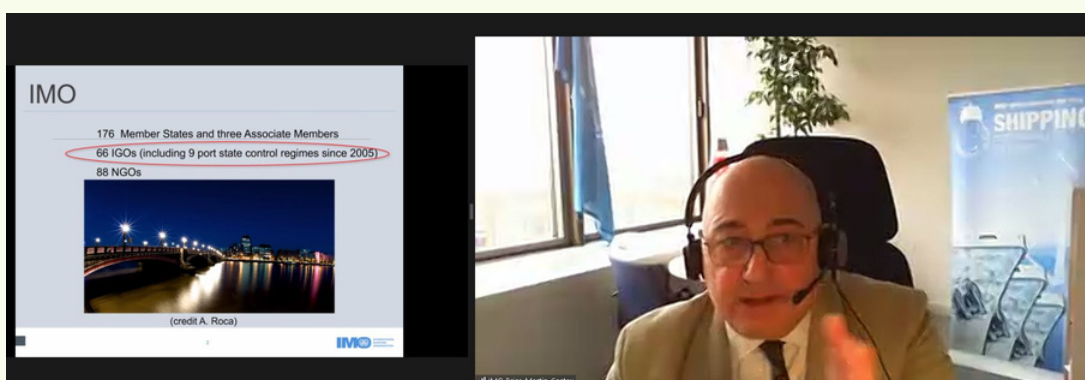
