


What is IMLI?

IMLI was established in Malta in 1988 under an Agreement concluded between the International Maritime Organization (IMO) and the Government of the Republic of Malta and started its first programme in 1989. Its main purpose was, and remains, to train officers, primarily from developing countries, in international maritime law.

Since its inception, through its research and other appropriate post-graduate programmes and courses, the Institute has been spearheading the dissemination of knowledge and expertise in the whole spectrum of international maritime law, with special reference to IMO regulations and procedures for the safety, security and efficiency of shipping, prevention of marine pollution from ships, and protection of life at sea. IMLI also offers unique training and guided practice in the techniques of maritime legislation drafting. Candidates are expected to assimilate the modus operandi and methods of implementation of IMO Conventions into national law.

Cognizant of the fact that ocean governance is critical to establish the safe and sustainable use of the oceans, IMLI continued in 2023 with its efforts to assist governments with developing the cadre of specialists necessary to shape national policies designed to achieve the Sustainable Development Goals encapsulated in the UN 2030 Agenda for Sustainable Development and a more effective global ocean governance in the interest of present and future generations.

Message from the IMLI Director

As the Director of the IMO International Maritime Law Institute (IMLI), it gives me great pleasure to present the 2023 Annual Report, which highlights the activities and achievements of the Institute in the past year.

2023 has been a year of transformation and growth. While the Institute continues to be the international centre for the training of specialists in the full the spectrum of international maritime law, during the year 2023 it reached new heights, both in the dissemination of knowledge and expertise in the international regime regulating every facet of shipping and law of the sea, as well as in promoting legislation drafting techniques to incorporate and effectively implement international maritime instruments, especially those developed by IMO, into national law.

IMLI concluded its 34th academic year on 30 June 2023. The 54 graduates of the Class of 2023 benefited from a unique training which honed their skills in international maritime law and equipped them with the necessary knowledge to return to their country and be vectors of positive change. They joined a formidable network of IMLI trained professionals who are promoting uniformity of law and adherence to international rules and prescriptions in 170 countries. I am particularly indebted to our donors and partners who continue to believe in what IMLI represents, and as I often say, believe in why IMLI remains relevant to the international maritime community.

The Institute adopted in 2023 its Strategic Plan for the period 2023-2027. The Plan places particular emphasis on the goals of the IMO's Integrated Technical Cooperation Programme while encouraging the Institute to maintain the highest standards of education and research. In the light of its global mission, the Institute projected its vision of upholding leadership in international postgraduate education and research, promoting diversity, equality, and inclusion in all its academic activities, demonstrating continuous improvement and skills, and contributing actively to the realization of the goals of the international maritime community. Through a set of principles and actionable strategic directions, the Institute reiterated, inter alia, its commitment to enhance capacity-building worldwide, especially in developing countries -

including Small Island Developing States and Least Developed Countries – promote world-class research of local, regional and global significance, expand its global outreach, support the maritime industry, and strengthen cooperation with leading institutions as well as exploring new partnerships with diverse actors operating in the maritime domain.

It is thanks to this vision that IMLI established a new initiative entitled "Continuous Professional Development and Representation". This new initiative has ensured that the Institute's personnel remain abreast with the latest developments in their respective fields of expertise and represent the Institute in international fora. The continuous professional development of IMLI's staff aligns with the Institute's goals of retaining faculty and staff of the highest standards and supporting their success, empowering them to inspire and prepare the next generation of maritime leaders.

In reasserting its commitment to the realization of the IMO's objectives, the Institute explored novel ways of delivering its mandate. The Institute enhanced its training in the areas of decarbonization

through dedicated lectures on MARPOL Annex VI, IMO GHG Strategy, the Climate Change Regulatory Framework, and best practices to make shipping and ports green. Students carried out research on the adequate implementation of MARPOL Annex VI in their countries, thereby contributing to the decarbonization of shipping. Moreover, becoming aware that the Maritime Single Window has become mandatory, the Institute conducted training activities on the implementation of the FAL Convention and the Maritime Single Window. The Institute raised awareness on the important role of cooperation between various national institutions to mitigate 'red tape' in maritime trade.

The security threats challenging shipping were also the focus of many discussions at IMLI. The Institute's students and other participants were made aware of the everevolving nature of these threats and the response of the international community, under IMO, on how to overcome the same. IMLI students were also introduced to the various measures to suppress fraudulent practices in ship registration and certificates of competence / proficiency of seafarers. The Institute is proud of its participation in the Study Group on Fraudulent Registration and Fraudulent Registries of Ships.

The academic year 2023-2024 which commenced on 9 October 2023 recorded the largest class ever in IMLI's history. 72 students from 40 countries entered the Institute's portals with the objective of serving the rule of international maritime law. The 35th IMLI class would embark on a journey of learning as well as professional and personal growth while celebrating a milestone of the Institute. 35 years since its establishment, the Institute continues to inspire and motivate maritime professionals from around the globe to pursue education which is pivotal to the successful implementation of the international regulatory framework.

I am proud to record that IMO bodies continue to express appreciation for the Institute's academic work. This recognition pays tribute to IMLI's initiative of offering a place, free of charge to a candidate nominated by the Permanent Missions to IMO. Despite relying exclusively on donations, this initiative is IMLI's way of paying forward the generosity of its supporters and giving back to the international maritime community. During 2023, over 180 candidates nominated by the Permanent Missions attended the numerous specialized courses offered by IMLI thereby enhancing their knowledge in the law of treaties, law of ports, seafarers' rights, environmental protection, ocean governance, international maritime security law, peaceful settlement of maritime disputes, and delimitation of maritime boundaries.

At IMLI we are conscious of the need to ensure that our training and teaching takes into account the latest

developments in international maritime law and the needs of the IMO Member States. In this respect, the Institute continued to cooperate with IMO and several other international organizations. It has been a real honour for me, to welcome to IMLI several senior IMO officers who delivered lectures (some of them in Malta) throughout the year 2023. These senior IMO officers, who support the Institute's academic activities, provide students with insights into the work of the Organization and the IMO's perspective on different issues, ranging from unmanned ships, enhancement of safety of merchant ships and fishing vessels, production of renewable energy at sea by offshore wind-farms, carbon neutral international shipping, digitalization of shipping, combatting various illegal acts at sea, to mention a few. These experts form part of the Distinguished Visiting Fellows Programme which in 2023 welcomed over 130 eminent practitioners, international officers, judges, and leading academics.

Pursuant to the cooperation between IMLI and FAO which recognizes the Institute as its capacity-building training partner, the Institute hosted the fifth "International Course on Fisheries Law" (in Spanish). The Course which took place between 23 October and 10 November 2023 welcomed 15 participants from seven countries (Costa Rica, Cuba, Ecuador, Honduras, Mexico, Panama, and Uruguay) who were able to enhance their knowledge in fisheries law and had the opportunity to apply such knowledge to practical situations. Lectures were delivered by Members of the IMLI Faculty, FAO officials, and international monitoring, control, surveillance and enforcement experts, together with eminent speakers, including Dr. Ximena Hinrichs Oyarce (Registrar of the International Tribunal for the Law of the Sea).

All these achievements would not have been possible without the commendable support of IMLI's Governing Bodies and the valuable work of the academic and administrative staff. I wish to express my deep appreciation to the Institute's donors who, through the provision of fellowships, have enabled the Institute to remain at the forefront of maritime legal education and training, for the benefit of our oceans.

The IMLI Governing Board is chaired by the IMO Secretary-General and is composed of eminent personalities from around the world with expertise in different areas of international maritime law and maritime affairs.

The Governing Board is assisted by the Director, the Financial and Human Resources Committee in matters relating to the funding and finances of the Institute and on administrative matters, including personnel, and the Academic Committee in matters related to the coordination and implementation of the study and research programmes of the Institute.

The 37th session of the IMLI Governing Board (the Board) was held on 24 July 2023 at the IMO Headquarters. The Governing Board reviewed the financial and academic progress of the Institute for the period between 1 July 2022 and 30 June 2023. The Director presented the respective

reports for the Board's comments and recommendations. Upon the Director presenting the financial report, the Board commended the Institute for its financial stability and for completing its financial year.

It congratulated the Director for his successful fundraising, particularly with respect to attracting new funding and further recorded its appreciation to all the Institute's donors and contributors.

Human Resources

In 2023, the Institute's resident faculty, under the supervision of the Director, continued to be responsible for the teaching of all subjects within the academic syllabi. The teaching of the resident faculty was complemented by the Distinguished Visiting Fellows Programme, which aims to introduce students to the latest developments, and offers networking opportunities which should serve students well when they return to their home countries. In 2023, distinguished visiting fellows came from world renowned Universities such as the Australian National University (ANU), Queen Mary University of London (QMUL), University of Ljubljana, World Maritime University (WMU), The Research Centre of the Sea and Maritime Law (DEHUKAM), Ankara University, U.S. Naval War College and others; while others came from international organizations such as the Comité Maritime International (CMI), the International Hydrographic Organization (IHO), the International Maritime Organization (IMO), the International Labour Organization (ILO), the International Maritime Satellite Organization (IMSO), the United Nations Conference on Trade and Development (UNCTAD), as well as the International Court of Justice (ICJ) and the International Tribunal for the Law of the Sea (ITLOS). Other visiting fellows were ambassadors, experts, and eminent practitioners. A list of these distinguished visiting fellows is provided in pages 38-39 of this Report.

The Resident Faculty also supervised 53 maritime legislation drafting projects and 53 dissertations/research projects, a list of which is provided in pages 40-42 of this Report. A unique feature of the IMLI training is its dedicated personal attention to the students. In addition to academic supervisors, the Institute appoints a moral tutor for each student to give support of a non-academic nature throughout the duration of studies.



IMLI Programmes

DURING 2023, IMLI OFFERED A PROGRAMME LEADING TO THE AWARD OF THE DEGREE OF MASTER OF LAWS (LL.M.) IN INTERNATIONAL MARITIME LAW, A PROGRAMME LEADING TO THE DEGREE OF MASTER OF HUMANITIES (M.HUM.) IN INTERNATIONAL MARITIME LEGISLATION, A RESEARCH DEGREE PROGRAMME LEADING TO THE AWARD OF THE DEGREES OF MAGISTER JURIS (M.JUR.) AND DOCTOR OF PHILOSOPHY (PH.D.) IN INTERNATIONAL MARITIME LAW, A PROGRAMME LEADING TO THE DEGREE OF MASTER OF PHILOSOPHY (M.PHIL.) IN INTERNATIONAL MARITIME LAW AND OCEAN POLICY IN COOPERATION WITH THE WORLD MARITIME UNIVERSITY (WMU), A PROGRAMME LEADING TO THE AWARD OF AN ADVANCED DIPLOMA IN INTERNATIONAL MARITIME LAW, AND SEVERAL SPECIALIZED SHORT COURSES IN ALL AREAS WITHIN IMLI'S SYLLABI.

LL.M. PROGRAMME IN INTERNATIONAL MARITIME LAW

The LL.M. programme in International Maritime Law was designed to respond to the shortage of legal experts, especially in the developing world, who possess the necessary skills to incorporate and efficiently implement international instruments into domestic legislation. Whereas there has been a plethora of international instruments which regulate the multifaceted aspects of international maritime law, some States have failed to translate them into effective national measures which will ensure uniform applicability across the oceans. Accordingly, the programme provides dedicated training in the drafting of maritime legislation, with emphasis on the techniques for the incorporation and implementation of IMO instruments into domestic legislation. With this in mind, the LL.M. programme not only studies maritime law from an international perspective, but looks on a comparative basis into the major legal systems in relation to maritime affairs. Through its international faculty composed of eminent academics, practitioners and members of the judiciary, the programme addresses current challenges facing the international maritime community and the various responses put forward to ensure safety of navigation, security of shipping, protection of the marine environment, safeguarding of human rights, and peaceful use of the oceans. This one academic year programme is open to candidates who hold a degree in law and are proficient in English.

M.HUM. PROGRAMME IN INTERNATIONAL MARITIME LEGISLATION

IMLI's specialized post-graduate programme leading to the Degree of Master of Humanities (M.Hum.) in International Maritime Legislation is open to candidates who hold an undergraduate degree from a recognized university or other academic institution in a related discipline to international maritime law and are proficient in English. The programme aims to respond to the needs of IMO Member States to have trained specialists in international maritime legislation drafting. Intensive drafting exercises are carried out to build the students' drafting skills so as to enable them to draft national legislation which effectively implements IMO instruments. The programme is suitable for qualified professionals working in the maritime field such as maritime administrations, port authorities, or other organizations concerned with maritime affairs.

RESEARCH DEGREE PROGRAMME IN INTERNATIONAL MARITIME LAW

IMLI offers a Research Degree programme leading to the award of the Degree of Magister Juris (M.Jur.) in International Maritime Law and the Degree of Doctor of Philosophy (Ph.D.) in International Maritime Law. Candidates are expected to undergo their studies in IMLI's Research Degree programme with a high degree of independence, thus, the programme can be largely undertaken from abroad. Candidates are assigned individual academic supervisors drawn from a list of internationally recognized experts.

M.PHIL PROGRAMME IN INTERNATIONAL MARITIME LAW /LEGISLATION AND OCEAN POLICY

IMLI and WMU offer a joint Master of Philosophy (M.Phil.) programme leading to the award of the Degree of Master of Philosophy (M.Phil.) in International Maritime Law and Ocean Policy. The programme is designed to train expert maritime professionals, immersed in the UN system structure and goals, to advocate sound policies and legislation which will support their sustainable development. This two-year programme recognizes that the current legal and institutional framework for ocean governance is limited in dealing with the emerging challenges in the field. As a result, the programme has identified that the fragmentation of both legal and institutional framework has led to the adoption of wellintended action occasioning unintended consequences for the oceans. Thus, the need for a new paradigm of ocean governance captured by this initiative is geared towards ensuring the establishment of effective ocean governance for the 21st century and beyond, as reiterated in Goal 14 of the UN 2030 Agenda for Sustainable Development.

ADVANCED DIPLOMA PROGRAMME IN INTERNATIONAL MARITIME LAW

The Advanced Diploma programme in International Maritime Law is designed to benefit professionals (including those at the most senior level) involved in maritime practice in both private and public sectors and who, because of their careers, are unable to be away from their jobs for a period of more than a few weeks / months per year.

The programme is structured on a credit system and, to be awarded the Advanced Diploma, candidates must earn a sufficient number of credits after successfully following and completing courses on distinct subject areas within either the Public International Maritime Law strand or the Private International Maritime Law strand. The credits offered broadly follow the subjects offered within the Institute's LL.M. programme. Candidates are required to have a degree from a recognized university or other academic institution, or must have


a comparable standard qualification, including relevant professional or practical experience, or both, recognized for this purpose by the Institute. This programme can be undertaken between one and five years.


SPECIALIZED SHORT COURSES

The Institute's teaching in the Master's programmes is based on a modular system which enables a number of applicants to attend these modules as independent short courses. The duration of such courses ranges between one to several weeks, depending on the subject area. At the conclusion of each short course, a certificate of attendance is awarded. The specialized short courses have attracted, over the years, a large number of participants who are especially interested in the training the Institute offers in a particular area. On request of government entities, the Institute also organizes tailor-made specialized courses in areas of interest to government officials who register their participation.

During the academic year 2023-2024, 50 students were enrolled in the LL.M. programme, 12 students in the M.Hum. programme and 1 student in the M.Jur. programme. These students hailed from 38 countries around the world. In addition, 4 students were enrolled in the Advanced Diploma Programme.

The academic year attracted 48 fellowships of which 23 were awarded to women candidates. During this year a total of 30 female students participated in the Institute's Master's programmes.

As in the previous academic years, the IMLI Programmes were conducted in such a methodical and consistent manner demonstrating IMLI's commitment to its mission of educating and training fellows in international Maritime Law, to the highest academic standards.

Also, as in the previous year, the Institute expanded its global outreach through the organisation of online specialized short courses for government officials in niche areas of international maritime law. These courses continued to be offered by the Institute in the reporting year and continued to be well attended by many in high-ranking positions including Permanent Representatives of the respective countries to the IMO, Ministers, Counsellors, Senior Foreign Officers, Government Officials and Maritime Professionals. They were exposed to the formidable body of work of the IMO in ensuring sustainable shipping for a sustainable planet and the vital role of other international organisations, courts, and tribunals in upholding the rule of international maritime law.
















IMLI, since its inception, has had the objective of enhancing capacity-building, especially in developing States. Recognizing that capacity-building is key in ensuring sustainable States' development, in particular in ensuring an effective international maritime regime, IMLI has spearheaded numerous academic activities in the areas of international maritime law, particularly regarding the effective implementation of existing IMO regulations and prescriptions.

During the year 2023, IMLI delivered specialized courses on the Law of Ports, Seafarers' Rights, Protection of the Marine Environment and Ocean Governance, International Maritime Security Law, Law of Treaties as well as Peaceful Settlement of Maritime Disputes and Delimitation of Maritime Boundaries. The very successful extensive programme which focuses on the operational aspects of IMO commenced for the fourth year in October 2023.

These specialized short courses, which may also be followed online, have enabled professionals who

may not leave their countries to attend courses in the Institute's premises to enhance their knowledge in all areas of international maritime law through IMLI's hybrid learning facilities. This has been the case for many country delegates to IMO who benefited from the free seats made available by the Institute. The free seat initiative was deeply appreciated by the Permanent Representatives of countries to IMO who applauded the Institute for its capacity-building efforts. These specialized courses have also contributed to the realization of IMLI's mission and to expand its global outreach.

IMLI COURSE ON THE LAW OF PORTS

This specialized Course, commenced on 9 February 2023, brought, together world experts in the field who provided practical perspectives and experiences. The Course was inaugurated by Ms. Beatriz Vacotto (Head of the Maritime Unit, International Labour Standards Department, International Labour Organization (ILO)). It addressed many aspects of maritime labour law, the functions of ILO, IMO, ITF and other organisations committed to the protection of seafarers' rights, the different international instruments dealing with seafarers, their rights and duties, with particular emphasis on the Maritime Labour Convention 2006 (MLC). The Course also included dedicated lectures on the sterling work of the ITF and ITF Seafarers' Trust in promoting seafarers' rights.

IMLI COURSE ON THE PROTECTION OF THE MARINE ENVIRONMENT AND **OCEAN GOVERNANCE**

This unique IMLI Course focused on the protection of the marine environment within the integrated global ocean governance of various maritime activities. Participants were introduced to the international regulatory framework, especially the IMO treaties, which contribute to the prevention of marine pollution as well as to cooperation, response and compensation in case of pollution incidents. The Course ran from 14 March to 27 May 2023, bringing together world experts in the field who provided practical



perspectives and experiences. It was inaugurated by Mr. Arsenio Antonio Domínguez Velasco (Director, Marine Environmental Division, IMO) and attended by nominated participants, including Ambassadors, Alternate Permanent Representatives, Ministers, Counsellors and Senior Foreign Officers nominated by their respective Permanent Representatives to the IMO.

IMLI COURSE ON INTERNATIONAL MARITIME **SECURITY LAW**

The Course covered the critical maritime security threats to the international rule of law at sea and the freedom of navigation. It addressed the gravity of these threats and the existing international laws and State practices deterring the same. The Course also focused on the current legal developments ensuring the safe navigation of ships, protection of offshore installations and coasts of maritime States as well as the contribution of international organisations, especially IMO, and regional cooperation in

overcoming maritime security threats. The Course ran from 8 March to 25 May 2023. Professor James Kraska (Chairman and Charles H. Stockton Professor of International Maritime Law, Stockton Center for International Law, US Naval War College) delivered the inaugural address.

IMLI COURSE ON THE LAW OF TREATIES

Following the overwhelmingly positive response by the international maritime community, the Institute launched on 9 November 2023 the fourth annual IMLI Course on the Law of Treaties. Professor Dr. Norman A. Martínez Gutiérrez (Director, IMLI) delivered the introductory address and

Through an analysis of the 1969 Vienna Convention on the Law of Treaties and developments found in jurisprudence and doctrine, this specialized Programme provided an overview of the Law of Treaties commencing with the value of treaties as a source of international law, and thereafter analyzing the most Office of Legal Affairs) essential features of treaties such as the adoption and authentication

of text, the States' expression of consent to be bound by treaties, entry into force, treaty interpretation, third States and treaties, methods of amendment, duration and termination, invalidity of treaties, treaties with international organizations and the relationship of treaties with domestic law. Among the participants, there were Ambassadors, Alternate Permanent Representatives of countries to IMO, Directors of Government Departments, and Diplomats, who were nominated by their respective Permanent Representatives to the IMO.

The Course, which ran from 19 April to 25 May 2023, brought together world experts in the field who provided practical perspectives and experiences and was attended by government nominated participants, including Ambassadors, Alternate Permanent Representatives and Senior Foreign Officers, who were nominated by their respective Permanent Representatives to the IMO.

SECOND "WOMEN ON BOARD" MENTORSHIP PROGRAMME





THE UNITED NATIONS GENERAL ASSEMBLY EXPRESSES APPRECIATION FOR THE WORK OF IMLI

IMLI's contribution to the international maritime community was recognized for the sixteenth consecutive year by the United Nations General Assembly, through its resolution A/RES/78/69 entitled "Oceans and the Law of the Sea", adopted on 5 December 2023, which tackles the main aspects of the 1982 United Nations Convention on the Law of the Sea and highlights the need for capacity building to enable States to achieve its aims. Through this Resolution, the United Nations General Assembly "Recognizes the importance of the work of the Malta-based International Maritime Law Institute of the International Maritime Organization, as a centre of education and training of specialists in maritime law, including government legal advisers and other high-level officials, mainly from developing States, confirms its effective capacity-building role in the field of international maritime law, shipping law and marine environmental law, and urges States, intergovernmental organizations and financial institutions to make voluntary financial contributions to the budget of the Institute which runs annually".



IMLI DIRECTOR REPORTS TO THE 110TH SESSION OF THE IMO LEGAL COMMITTEE

During the 110th session of the IMO Legal Committee, the IMLI Director reported on the Institute's activities for the year 2022 under the Agenda Item "Technical Cooperation Activities related to Maritime Legislation". Following the Director's Report, delegates from Antigua and Barbuda, the Bahamas, CMI, Ecuador, Georgia, Guatemala, IIDM, India, Jamaica, Kenya, Malta, Mexico, Nigeria, Panama, the Philippines, Suriname, and Thailand expressed heartfelt congratulations to Professor Martínez on his appointment as the new IMLI Director and thanked IMLI as it continues to be a centre of excellence in the training of maritime law specialists and building capacity in the area of international maritime law and implementation of international instruments. The delegates recognized IMLI's work in providing the know-how and expertise which is

needed in developing countries, particularly Small Island Developing States, to bridge the gap in the development of national policies and laws. Delegates appreciated the research and academic activities in the field of maritime legislation undertaken by IMLI which are contributory to capacity-building of States and the launching of maritime leaders worldwide. Particular thanks were extended to the Institute for its specialized courses which by being delivered in a hybrid mode have enabled officers from many countries in attending the same.

THE WORK OF IMLI IS PRAISED DURING THE 73RD SESSION OF THE IMO TECHNICAL COOPERATION COMMITTEE AND 130TH SESSION OF THE IMO COUNCIL

During the 73rd session of the IMO Technical Cooperation Committee, the Committee praised IMLI's work, congratulated the new management on the Institute's capacity-building efforts, in particular on research on the law of the sea and the application of international instruments into national legislation, from which a growing number of government representatives had benefited. The delegation of Malta expressed the continuous support of its Government for IMLI, which included the financing of the recently refurbished lecture hall, while various delegations reconfirmed their support through financial contributions for fellowships and training activities alike, including the Government of Malaysia's annual fellowship support and in-kind contribution for the development of IMLI's facilities.

During the 33rd session of the IMO Assembly, the IMO Secretary-General observed that IMLI supports the IMO capacity-building goals through the education and training of legal experts from around the world in maritime matters, particularly in legislative drafting techniques designed to support the incorporation of IMO's international maritime instruments into national law. The Secretary-General recognized the work of the former IMLI Director and noted that, "the commitment and steadfast determination Professor Attard showed has been passed down to the new Director, Professor Dr. Norman Martínez Gutiérrez who as a longstanding IMLI staff member and former student has the Institute very close to his heart, and I am confident he will drive the Institution to a new era of innovation, transformation, and enduring academic excellence."

RECOGNITION OF THE M.JUR. PROGRAMME IN INTERNATIONAL MARITIME LAW

During the reporting year, the Institute was proud to announce that the quality training being delivered in all of its programmes is continuously being recognized by the Malta Further and Higher Education Authority. Most recently, Mr.

Lawrence Azzopardi (Head of Accreditation Licensing Validation and Quality Assurance, Malta Further and Higher Education Authority) informed the IMLI Director that the Degree of Magister Juris (M.Jur.) in International Maritime Law has been recognized as meeting the standards required for a master's degree in Malta, falling under MQF Level 7. The recognition of this programme is another great accomplishment for the Institute.

IMLI JOINS THE INTERNATIONAL MARITIME COMMUNITY IN CELEBRATING WORLD MARITIME DAY

IMLI joined the international maritime community in celebrating World Maritime Day the theme of which for 2023 was "MARPOL at 50 - Our Commitment Goes On". The theme is a reflection of IMO's efforts to protect the marine environment and the Organization's commitment to continue to do so. The IMLI Director noted that "the adoption of MARPOL in 1973, one year after the 1972 United Nations Conference on the Human Environment in Stockholm, was a strong signal to the world of the Organization's commitment to protect the marine environment from all types of vessel-source pollution. This international instrument which has come to be a pillar of shipping, has been amended numerous times to ensure that the legal framework meets the needs of the industry. IMO's efforts however would be diluted, if States were not to adequately implement the provisions of this instrument. It is in this area where IMLI plays a vital role and assists the Organization's goals. For 35 years now, IMLI has promoted the adequate implementation of MARPOL which has been chosen by hundreds of students as their maritime legislation drafting project. As such, IMLI's commitment to contribute to the achievement of IMO's objectives goes on. To promote World Maritime Day 2023 IMLI was lit blue on 28 September 2023, after dark.

The Nippon Foundation and IMLI Cooperation can be traced back 20 years, when in 2004 the first batch of The Nippon Foundation sponsored fellows graduated. This fruitful collaboration continues today under the joint project entitled the "Human Resources Development Project for the Advancement of a More Effective Legal Order for the Oceans" which, to date, has rendered support to deserving Government nominated scholars, from 82 developing countries. This collaboration is illustrative of the vision and commitment with which the Foundation continues to support all things maritime. Thanks to the Foundation's generosity and its staunch belief in IMLI's capacity-building mission, 212 Fellows have successfully graduated from IMLI. A recent study carried out by the Institute has revealed that many of these Fellows are engaged in national, regional, or international maritime affairs and are making invaluable contributions.

Thirteen Fellows were sponsored by The Nippon Foundation for the academic year 2022-2023. The sponsored students once again demonstrated their outstanding academic ability by taking home several prizes which were awarded at the Graduation Ceremony including the IMO Secretary-General's Prize for Best Dissertation and the Transport Malta Prize for Best Performance in Shipping Law. The Sasakawa Prize for the Best Performing Nippon Foundation Scholar was awarded to Mr. Martin Maada George from Sierra Leone. IMLI has followed up on the progress of these Fellows upon completion of their studies and found that many are already contributing to their national maritime sector.

Sixteen Fellows were sponsored by The Nippon Foundation for the academic year 2023-2024, of whom thirteen Fellows are pursuing studies in the LL.M. programme and three are following the M.Hum. programme.

The project also contributes by sponsoring four teaching positions at the Institute: The Professorship in Marine Environmental Law and the Lectureships on International Maritime Security Law, Global Ocean Governance and International Maritime Law. These lecturers are playing a vital role in shaping the minds of future maritime leaders.

The IMO

IMO continues to support IMLI's funding requirements by providing fellowships to deserving Government nominated candidates who wish to pursue post graduate studies in the Institute's LL.M. and M.Hum. programmes. This is a fruitful collaboration given IMLI's mission which is to provide capacitybuilding for the implementation of a significant number of IMO treaties and regulations governing every facet of shipping. As stated by the IMO Secretary General, Mr. Kitack Lim, at the 34th graduation ceremony: "The International Maritime Organization (IMO), takes enormous pride in the work of the IMO International Maritime Law Institute (IMLI) and assigns immense value to the education and training provided to the many maritime professionals who enrol every year, and we are always overjoyed to see another generation of maritime leaders return to their home countries, determined to contribute to the realization of the IMO goals and objectives adding to the Institute's impressive record of producing graduates of great distinction year upon year."

For the academic year 2022-2023, IMO fully sponsored 18 students of whom 13 pursued the LL.M programme, and five, the M.Hum. programme. The selected candidates realized IMO's policy to support capacity-building in Small Island Developing States and Least Developed Countries. The Professor David Attard Prize for Best Performance in the Law of the Sea, Dr. Kofi Mbiah's Prize for the Best Performing African Scholar and the REMPEC Marine Environment Law Prize were awarded to IMO Fellows, demonstrating the high standards of academic excellence to which they aspired.

IMO continued its support to IMLI by providing 20 fellowships for the academic year 2023-2024. The selected Fellows work for their national administrations and hail from developing countries, especially Small Island Developing States and Least Developed Countries. They are being exposed to the full spectrum of international maritime law and are being inspired to render a valuable service to their nations thereby contributing to the goal of sustainable development.

The International Transport Workers' Federation (ITF) Seafarers' Trust

Since 2019, the International Transport Workers' Federation (ITF) Seafarers' Trust has been committed to providing fellowships annually to five deserving candidates. This tradition was continued with five students from Egypt, Guinea-Bissau, Lebanon, South Africa, and Tanzania being sponsored for the academic year 2022-2023. The Trust also sponsors the ITF Seafarer's Trust Prize on Seafarers' Law which was awarded in 2023 to a Maltese student. To date 29 students from 26 countries have been proud recipients of sponsorship, from the Trust.

The Trust continued its support for the academic year 2023-24 by sponsoring another five students from developing economies who, upon completion of their studies at IMLI, will advocate for the rights of seafarers worldwide, in line with international rules and prescriptions.

The Lloyd's Register Foundation

The Lloyd's Register Foundation was established to fund the advancement in transport, science, engineering, and technology education, training and research worldwide for the benefit of all, and to enhance the safety of life and property at sea, land and in the air. Since 2002, the Foundation has been generously funding three nominated candidates to IMLI. In addition, it awards the LRF Prize for Best Performing Lloyd's Register Foundation Scholar to one of the three candidates who excels in the IMLI Masters' programmes. IMLI records with pride that several of the LRF sponsored Fellows have made substantial contributions to their maritime sector, especially in academia, by disseminating knowledge and expertise to ensure sustainable shipping in sustainable oceans. To date the Foundation has funded the training of over 50 maritime professionals from 41 States.

International Group of P&I Clubs Fellowship

The International Group of P&I Clubs comprising thirteen P&I Clubs, provides marine liability cover (protection and indemnity) for approximately 90% of the world's ocean-going tonnage. The aim of the Group includes, inter alia, promoting insurance related interests of shipping companies through a unified and collective voice. For the first time in 2021, the Group provided a full fellowship to sponsor the training of a government official from the Gambia Maritime Administration. This was followed in 2022 by the sponsorship of an applicant from Mexico, and in 2023 of an applicant from Ghana.

International Chamber of Shipping

The International Chamber of Shipping is the global trade association for shipowners and operators which represents the world's national shipowner associations and over 80% of the world merchant fleet. A long-standing supporter of IMLI, the Chamber extended its collaboration with the Institute in the academic year 2022-2023 through the provision of one fellowship to a female member of the Philippines Coast Guard.

Another female government officer from Kenya benefited from the generous funds of the Chamber, in 2023.

European Maritime Safety Agency

In 2023, the European Maritime Safety Agency (EMSA) awarded the Institute a contract for services in the amount of Euro 600,000. Through this contract, EMSA will sponsor the studies of suitable government officers from beneficiary countries, in the Institute's masters' and research degree programmes. For the academic year 2023-2024, EMSA sponsored a government officer from the Ukraine who is pursuing studies in the LL.M. programme.

National Governments

Some students have been fortunate to receive sponsorship from the Governments of a few countries, which recognize the value of IMLI's mission for capacity-building in the maritime sector. For the academic year 2022-2023, Nigeria funded three Nigerian students, two for the LL.M. programme and one for the M.Phil. programme, respectively. The Government of the Republic of Korea fully sponsored two students, one from Tunisia and the other from Yemen both of whom pursued the M.Hum. programme. The Argentinian Navy sponsored one of its own members, who went on to win the Chartered Institute of Logistics and Transport (Malta Branch) Prize for the Best Performance in Maritime Transport Law. The Philippine Coast Guard too sponsored one of its own members. The Government of Malaysia sponsored two students from Seychelles and India who followed the LL.M. and M.Hum. programmes respectively. The Indian student went onto win the coveted CMI prize for the Best Overall Performance. The Government of Malta, in addition to hosting IMLI on the premises of the University of Malta Campus also sponsored the Government of Malta Prize for the Best Maritime Legislation Drafting Project, which was awarded to a self-funded female student from Ghana.

For the academic year 2023-2024, Nigeria sponsored two students for the LL.M. and M.Phil programmes respectively. The Government of the Republic of Korea sponsored two students, one from the Democratic Republic of Congo and the other from Tanzania, for the LL.M. programme. The Government of Malaysia too sponsored two students, one from Sri Lanka and the other from Tanzania for the LL.M. programme. This academic year also saw the sponsorship of two students from the Ghana Ports and Harbours Authority for the LL.M. Programme and two from Saudi Arabia, sponsored by the Saudi Border Guards and Royal Saudi Naval Forces respectively, for the M.Hum. programme.



The Institute has steadily built up its Fund Balances and Reserves attributed to the surplus generated over the years since inception, which is transferred to form part of the Fund Balances and Reserves.

The Fund Balances and Reserves of EUR4.83 million as at 31 December 2023, can cover 205.3% or 24.6 months of sustainable operational support of the Institute.

In the beginning of 2024, the External Auditor of IMO, The Audit Board of the Republic of Indonesia (BPK), conducted the annual audit of the Institute's financial statements for the year ending 31 December 2023 and thereafter, issued an umodified audit opinion. Moreover, in the report, the Auditor declared that overall, the key financial indicators remain sound and an analysis of the key financial ratios demonstrates that the Institute has the ability to meet all its liabilities.
