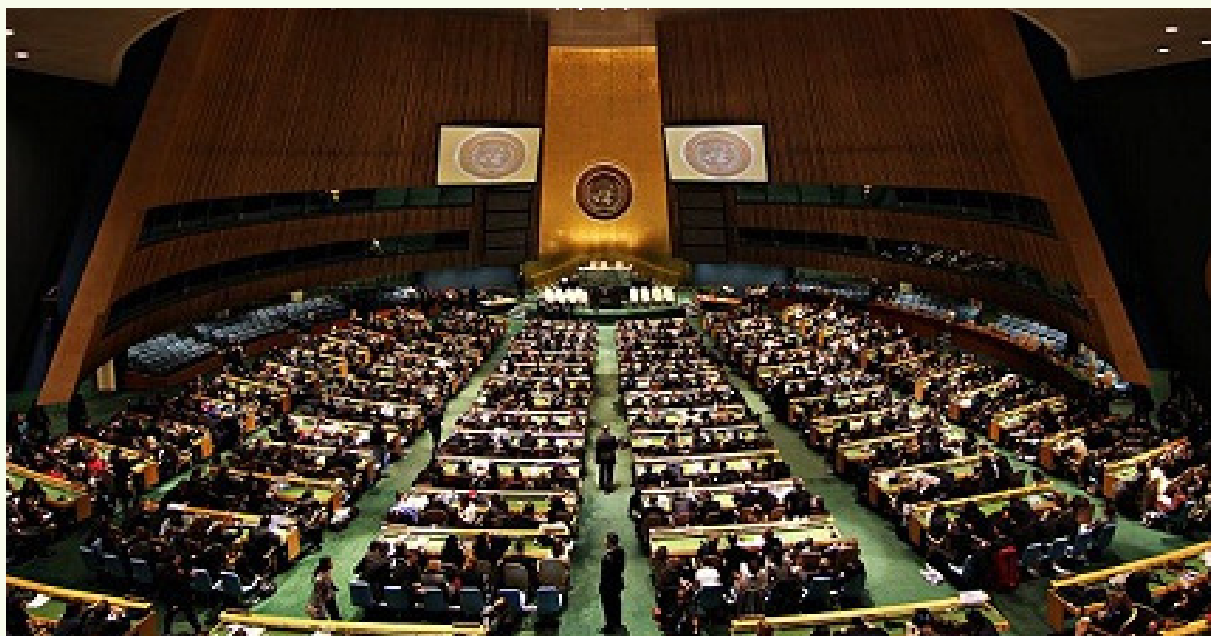

IMLI'S WORK RECOGNIZED FOR THE SEVENTEENTH CONSECUTIVE YEAR BY THE UNITED NATIONS GENERAL ASSEMBLY

The United Nations General Assembly, during its seventy ninth session, adopted on 3 December 2024 Resolution *A/RES/78/69* entitled "*Oceans and the Law of the Sea*". The General Assembly, through this Resolution, recognized for the seventeenth consecutive year the contribution of the IMO International Maritime Law Institute (IMLI) in capacity-building.



Paragraph 32 of the document states:

[...] Recognizes the importance of the work of the Malta-based International Maritime Law Institute of the International Maritime Organization, as a centre of education and training of specialists in maritime law, including government legal advisers and other high-level officials, mainly from developing States, confirms its effective capacity-building role in the field of international maritime law, shipping law and marine environmental law, and urges States, intergovernmental organizations and financial institutions to make voluntary financial contributions to the budget of the Institute which runs annually;

The IMLI Director and Staff are proud of this continued recognition of the Institute's work to enhance capacity-building in the full spectrum of international maritime law.
