DRAFTING FOR DRAFTERS WORKSHOP HOSTED AT IMLI

The Institute had the distinct pleasure of hosting, for the first time, the *Workshop on General Principles of Drafting National Legislation to Implement IMO Conventions* between 15 and 23 January 2025.

The Workshop, which was previously organized by IMO in London, aims to enhance capacity in the drafting of national legislation which adequately implements IMO conventions. Recognizing that IMO conventions are not self-executing but rely on domestic law for their implementation and enforcement, the Workshop delved – through numerous presentations and practical exercises – into the techniques drafters need to have when drafting such implementing legislation.







The Workshop included lectures delivered by the IMLI Faculty, together with presentations, discussions, and practical exercises delivered by IMO officers and IMO consultants.

Considering IMLI's global outreach, the Workshop provided an opportunity to disseminate knowledge to and hone the skills of 60 maritime professionals hailing from

38 countries. IMLI is very proud of this initiative which consolidates further its status as a centre of excellence in the full spectrum of international maritime law and of the enhancing capacity in effective incorporation and adequate implementation of especially international treaties. those promulgated by IMO.

The IMLI Director would like to extend his appreciation to the IMO Legal Affairs and External Relations Division, particularly its Director, for being instrumental in the delivery of this very important Workshop at IMLI.
