




IMLI COURSE ON THE PROTECTION OF THE MARINE ENVIRONMENT AND OCEAN GOVERNANCE

IMLI CLASS PARTICIPATES IN THE ANNUAL MOOT COURT ON MARINE INSURANCE

Following the comprehensive lectures on the topic of *Marine Insurance*, delivered by Professor Dr. Dr. H.C. Marko Pavliha (Head, Law Department, University of Ljubljana, Faculty of Maritime Studies and Transportation, Slovenia; Member, IMLI Governing Board), students of the IMLI Class participated in the Annual Moot Court on the same subject.

The Class was divided into three teams, namely the Arbitral Tribunal, the Insured (Policyholder) and the Insurer (Insurance Company). They were given a Case Study within the area of *Marine Insurance* which they had extensively covered during their lectures with Professor Pavliha. At the end of the pleadings by both sides, the Arbitrators delivered an Arbitral Award.

This exercise gave the students a hands-on approach, enabling them to put their training and knowledge into practical use.
