IMLI STUDENTS DELIVER PRESENTATIONS ON BASELINES

The IMLI Class of 2024-2025 delivered on 20 February presentations on Baselines. This exercise, which forms part of the module on "Introduction to the Law of the Sea and Humanitarian Law and Law of the Sea Specific Regimes I", was coordinated and presided over by Members of the IMLI Faculty.

In this exercise, the students were required to provide an overview of the international rules of the law of the sea on baselines and the contribution of jurisprudence in the consolidation of the said rules. They were also required to present the baselines drawn by their respective countries and explain whether they are in conformity with international law. Further, the exercise required detailed submission on the maritime zones of their county, making specific reference to the enabling Act or Legislation, if applicable.

Through their presentations, the students demonstrated a clear understanding of this very important area of the law.
