


## THE IMLI COURSE ON PEACEFUL SETTLEMENT OF MARITIME DISPUTES AND DELIMITATION OF MARITIME BOUNDARIES

During the academic year 2024-2025, IMLI delivered its annual Course on the Peaceful Settlement of Maritime Disputes and Delimitation of Maritime Boundaries.

The Course provided a comprehensive introduction to, and an analysis of, various international maritime dispute settlement mechanisms as well as the process of boundary-making and the alternative arrangements available to States, including provisional measures.

Additionally, the Course explored the principal methods of settlement of maritime disputes under UNCLOS and examined its relevant provisions.





The Course also examined how international courts and tribunals have not only applied the provisions of the Convention but have also elaborated upon them, establishing principles or clarifying the existing rules that have crystallized into customary international law.




