What is IMLI?

The IMO International Maritime Law Institute (IMLI) was established in Malta in 1988 under an agreement concluded between the International Maritime Organization (IMO) and the Government of the Republic of Malta and started its first programme in 1989. Its main purpose was, and remains, to train officers, primarily from developing countries, in international maritime law.

Since its inception, the Institute has been at the forefront of disseminating knowledge and expertise across the full spectrum of international maritime law. Through its research and specialized postgraduate programmes and courses, it places particular emphasis on IMO regulations and procedures concerning the safety, security, and efficiency of shipping; the prevention of marine pollution from ships; and the protection of life at sea. IMLI also offers unique training and guided practice in the techniques of maritime legislation drafting. Candidates are expected to assimilate the modus operandi and methods of implementation of IMO Conventions into national law.

Cognizant of the fact that ocean governance is critical to establish the safe and sustainable use of the oceans, IMLI continued in 2024 with its efforts to assist governments with developing the cadre of specialists necessary to shape national policies designed to achieve the Sustainable Development Goals encapsulated in the UN 2030 Agenda for Sustainable Development and a more effective global ocean governance in the interest of present and future generations.

Message from the IMLI Director

As the Director of the IMO International Maritime Law Institute (IMLI), it gives me great pleasure to present the 2024 Annual Report, which highlights the activities and achievements of the Institute in the past year.

In 2024, IMLI celebrated 35 years in serving the rule of international maritime law. For 35 years the Institute has devotedly trained the maritime leaders of tomorrow, pledging itself to continue steadfastly in this path in the future. From its modest beginnings, the Institute has been transformed into an international centre for the training of specialists in the full the spectrum of international maritime law, engaging successfully both in the dissemination of knowledge and expertise in the international regime regulating every facet of shipping and law of the sea, as well as in promoting legislation drafting techniques to incorporate and effectively implement international maritime instruments, especially those developed by IMO, into national law.

History has it recorded that Dr. C.P. Srivastava, the then Secretary-General of IMO, was instrumental in the establishment of the Institute, the main purpose of which would be to train lawyers from developing countries in private and public international maritime law, thereby bridging the gap between developed and developing countries. Thanks to his tireless efforts, the Institute was launched in 1988 and started its

first academic year in 1989. This enthusiasm for and dedication to IMLI has been shared by all subsequent Secretaries-General and Mr. Arsenio Domínguez, the present IMO Secretary-General and Chairman of the IMLI Governing Board, who has been supporting IMLI and its mission since the beginning of his tenure.

To celebrate the Institute's IMLI's 35th Anniversary, Mr. Domínguez hosted a celebration to commemorate this remarkable milestone during the 111th Session of IMO Legal Committee at the IMO Headquarters in London on 22 April 2024. The Celebration was attended by Ministers, IMLI Governing Board Members, Diplomatic Representatives, IMLI students and graduates, as well as several distinguished personalities from all over the world. It was a great pleasure to hear him reaffirming the IMO's appreciation to the Institute by noting that that IMLI has gone from strength to strength and that its crucial role is as much needed now as it was 35 years ago.

I was also elated to hear Dr. Yohei Sasakawa (Chairman, The Nippon Foundation) noting in his Address during this commemorative event that studying at IMLI is a prestige due to the global output of its Graduates. Dr. Sasakawa's address was heralded by that of Mr. Christopher Cutajar's (Permanent Secretary of the then Ministry for Foreign and European Affairs and Trade of Malta), who also praised the work of IMLI and reiterated Malta's commitment to the continued support of the Institute. I was also happy to see that, throughout the Session, delegates recognized and praised the role of IMLI in capacity-building.

I am pleased to report that on this 35th year, for the first time, the IMLI Class of 2024 was in full attendance to celebrate at IMO, together with the Institute's academic staff. This was a deviation from the usual tradition of the Institute's organized class field trip to London at the end of the Academic Year immediately after the Graduation ceremony. I am happy to report that this change gave the Class the opportunity to visit the usual landmark maritime institutions and to fully benefit from the unique opportunity to act as observers during the IMO Legal Committee 111th Session's proceedings.

The celebration of IMLI's 35th anniversary spanned throughout the year following the celebrations at IMO, in a befitting manner for all its herculean achievements, starting with a Panel Discussion held during the 35th Anniversary Celebration at IMO on IMLI's Legacy and Future Trajectory in Enhancing Global Maritime Legal Expertise. This was followed by its first International Conference entitled "Promoting the Implementation of IMO Objectives through Maritime Legislation",

in Collaboration with the Ministry for Foreign and European Affairs and Trade of Malta on 17 June 2024. This Conference, I am pleased to report, was a huge success, attended by several eminent speakers and guests, from all over the world, including IMLI Graduates as well as many distinguished personalities. The subject matter of the Conference was discussed by six panels, each with four panellists and a moderator, tackling various crucial, contemporary and evolving topics in the maritime world. In addition, during the 35th Graduation Ceremony, the Institute set up an exhibition of a specially designed set of banners which were displayed in the Institute's premises for viewing. Each banner vividly chronicled the journey of IMLI, capturing the essence and achievements of every academic year since the inception of the Institute. Through photos of students and memorable events at IMLI, this exhibition weaved together a rich tapestry of IMLI's illustrious history.

To further mark this momentous occasion, a commemorative plaque was unveiled by Mr. Arsenio Domínguez at the Institute's premises, in the Grotius Quadrangle, following the 35th Annual Graduation Ceremony.

In furtherance of and cementing the bonds of cooperation with our sister institute, World Maritime University (WMU), I was invited by Professor Max Mejia (President of WMU) to Malmö, Sweden for a visit to WMU where I delivered the 35th Anniversary IMLI Lecture entitled "Legal Drafting for Implementation of International Conventions: Considerations when Drafting Conventions—National Law Challenges—Implementation of Conventions" to WMU students. At the end of my visit, I am pleased to report the warm celebratory reception given by Professor Mejia in honour of IMLI's 35th Anniversary.

I would also like to report that a commemorative 120-page brochure was published, celebrating the Institute's milestones over its 35-year journey. The brochure which provides a historical account of IMLI's 35 Years of academic excellence can be found on the IMLI's website.

IMLI concluded its 35th academic year on 29 June 2024. During the Ceremony, 69 students from 38 countries graduated from the Institute's various programmes. 50 students were awarded the Degree of Master of Laws (LL.M.) in International Maritime Law, 12 students were awarded the Degree of Master of Humanities (M.Hum.) in International Maritime Legislation and seven students were awarded an Advanced Diploma in International Maritime Law. The 2024 Graduates now form part of an elite network of international maritime



law specialists, who have also received sterling training at IMLI.

Over the years, IMLI has produced a stellar body of experts and qualified maritime professionals who are now, collectively, making positive and valuable contributions to the causes espoused by IMO. Today, IMLI remains a lasting and

greatly appreciated testimony of the foresight, diligence and commitment not only of its visionary founders, but also of the many others who have followed in their wake, and of its graduates who are today such a strong foundation for the future development of international maritime law. Every time I attend IMO meetings, I am proud to see the increasing number of IMLI graduates attending the same, some of whom are now Directors of IMO Divisions, IMO staff and many are delegates at IMO meetings. For this success, I recognize the support of the IMO Secretaries-General, past and present, who, despite their many commitments have successively and generously supported the work of the Institute.

At this juncture, I would like to also take this opportunity to pay tribute to the many donors, supporters and benefactors who, over the years, have provided funding, in-kind support, and expertise necessary for the Institute's continued operations. While I may not be able to single them all out in this message, since there have been so many contributions and all have been very gratefully received over the last 35 years, I feel special mention should be made to the IMO, The Nippon Foundation, the ITF Seafarers's Trust and Lloyd's Register Foundation, whose support for IMLI have been unstinting and outstanding over many years. I also wish to recognise with sincere appreciation the support of the European Maritime Safety Agency, the International Group of P&I Clubs, the International Chamber of Shipping, the Australian Maritime Safety Authority, the Comité Maritime International, and a number of Governments, including, Kingdom of Saudi Arabia, Malaysia, Nigeria, Republic of Korea, as well as other organizations and governments who have supported the Institute in one form or another. I also wish to acknowledge the Governments of many developing States who have, over the past several years, not only relied on donor funding to train their personnel but have proudly personally invested in their training.



Not only did this Resolution formally recognize, for the first time, the importance of IMLI's work as a centre of education and training, but it also urged States, intergovernmental organizations financial financial institutions to make contributions to the Institute's budget. In December 2024, I am proud to report that IMLI's contribution to the international maritime community was recognized for the seventeenth consecutive year by the United Nations General Assembly, through its Resolution A/ RES/78/69.

The IMLI Governing Board is chaired by the IMO Secretary-General and is composed of eminent personalities from around the world with expertise in different areas of international maritime law and maritime affairs.

The Governing Board is assisted by the Director, the Financial and Human Resources Committee in matters relating to the funding and finances of the Institute and on administrative matters, including personnel, and the Academic Committee in matters related to the coordination and implementation of the study and research programmes of the Institute.

The 38th session of the IMLI Governing Board was held on 24 July 2024 at the IMO Headquarters. The Governing Board reviewed the financial and academic progress of the Institute for the period between 1 July 2023 and 30 June 2024. The Director presented the respective reports

for the Board's comments and recommendations. Upon the Director presenting the financial report, the Board commended the Institute for its financial stability and for completing its financial year.

The Board congratulated and thanked the IMLI Director and the Institute's Staff for their sterling work in training the maritime leaders of tomorrow. It then proceeded to consider reports on the Institute's matters including those of a financial and academic nature, as well as IMLI's contribution to the IMO Goals and UN 2030 Sustainable Development Agenda. The Board noted with satisfaction the Institute's efforts to enhance its global outreach and the appreciation by the General Assembly of the United Nations and IMO Bodies for the Institute's work. The Board also considered a report on the institutional co-operation and partnerships, and it commended the Institute for its work in this field.

Human Resources

In 2024, the Institute's resident faculty, under the supervision of the Director, continued to be responsible for the teaching of all subjects within the academic syllabi. The teaching of the resident faculty was complemented by the Distinguished Visiting Fellows Programme, which aims to introduce students to the latest developments, and offers networking opportunities which should serve students well when they return to their home countries. In 2024, distinguished visiting fellows came from world renowned Universities such as the Australian National University, Queen Mary University of London, University of Ljubljana, World Maritime University, The Research Centre of the Sea and Maritime Law (DEHUKAM), Ankara University, U.S. Naval War College and others; while others came from international organizations such as the International Hydrographic Organization, the International Maritime Organization, the International Labour Organization, the International Maritime Satellite Organization, the United

Nations Conference on Trade and Development, as well as the International Court of Justice and the International Tribunal for the Law of the Sea. The Comité Maritime International has also supported the Institute either through visits of its President and members or by sponsoring the visits of distinguished speakers. Other visiting fellows were ambassadors, experts, and eminent practitioners. A list of these distinguished visiting fellows is provided in pages 56-59 of this Report.

The resident faculty also supervised 62 maritime legislation drafting projects and 62 dissertations/research projects, a list of which is provided in pages 60-64 of this Report. A unique feature of the IMLI training is its dedicated personal attention to the students. In addition to academic supervisors, the Institute appoints a moral tutor for each student to give support of a non-academic nature throughout the duration of studies.





IMLI Programmes

DURING 2024, IMLI OFFERED A PROGRAMME LEADING TO THE DEGREE OF MASTER OF LAWS (LL.M.) IN INTERNATIONAL MARITIME LAW, A PROGRAMME LEADING TO THE DEGREE OF MASTER OF HUMANITIES (M.HUM.) IN INTERNATIONAL MARITIME LEGISLATION, A RESEARCH DEGREE PROGRAMME LEADING TO THE AWARD OF THE DEGREES OF MAGISTER JURIS (M.JUR.) AND DOCTOR OF PHILOSOPHY (PH.D.) IN INTERNATIONAL MARITIME LAW, A PROGRAMME LEADING TO THE DEGREE OF MASTER OF PHILOSOPHY (M.PHIL.) IN INTERNATIONAL MARITIME LAW/LEGISLATION AND OCEAN POLICY IN COOPERATION WITH THE WMU, A PROGRAMME LEADING TO THE AWARD OF AN ADVANCED DIPLOMA IN INTERNATIONAL MARITIME LAW, AND SEVERAL SPECIALIZED SHORT COURSES IN ALL AREAS WITHIN IMLI'S SYLLABI.

LL.M. PROGRAMME IN INTERNATIONAL MARITIME LAW

The LL.M. programme in International Maritime Law was designed to respond to the shortage of legal experts. especially in the developing world, who possess the necessary skills to incorporate and efficiently implement international instruments into domestic legislation. Whereas there has been a plethora of international instruments which regulate the multifaceted aspects of international maritime law, some States have failed to translate them into effective national measures which will ensure uniform applicability across the oceans. Accordingly, the programme provides dedicated training in the drafting of maritime legislation, with emphasis on the techniques for the incorporation and implementation of IMO instruments into domestic legislation. With this in mind, the LL.M. programme not only studies maritime law from an international perspective but looks on a comparative basis into the major legal systems in relation to maritime affairs. Through its international faculty composed of eminent academics, practitioners and members of the judiciary, the programme addresses current challenges facing the international maritime community and the various responses put forward to ensure safety of navigation, security of shipping, protection of the marine environment, safeguarding of human rights, and peaceful use of the oceans. This one academic year programme is open to candidates who hold a degree in law and are proficient in English.

M.HUM. PROGRAMME IN INTERNATIONAL MARITIME LEGISLATION

IMLI's specialized post-graduate programme leading to the Degree of Master of Humanities (M.Hum.) programme in International Maritime Legislation is open to candidates who hold an undergraduate degree from a recognized university or other academic institution in a related discipline to international maritime law and are proficient in English. The programme aims to respond to the needs of IMO Member States to have trained specialists in international maritime legislation drafting. Intensive drafting exercises are carried out to build the students' drafting skills so as to enable them to draft national legislation which effectively implements IMO instruments. The programme is suitable for qualified professionals working in the maritime field such as maritime administrations, port authorities, or other organizations concerned with maritime affairs.

RESEARCH DEGREE PROGRAMME IN INTERNATIONAL MARITIME LAW

IMLI offers a Research Degree programme leading to the award of the Degree of Magister Juris (M.Jur.) in International Maritime Law and the Degree of Doctor of Philosophy (Ph.D.) in International Maritime Law. Candidates are expected to undergo their studies in IMLI's Research Degree programme with a high degree of independence, thus, the programme can be largely undertaken from abroad. Candidates are assigned individual academic supervisors drawn from a list of internationally recognized experts.

M.PHIL PROGRAMME IN INTERNATIONAL MARITIME LAW/LEGISLATION AND OCEAN POLICY

IMLI and WMU offer a joint Master of Philosophy (M.Phil.) programme leading to the award of the Degree of Master of Philosophy (M.Phil.) in International Maritime Law/Legislation and Ocean Policy. The programme is designed to train expert maritime professionals, immersed in the UN system structure and goals, to advocate sound policies and legislation which will support their sustainable development. This twoyear programme recognizes that the current legal and institutional framework for ocean governance is limited in dealing with the emerging challenges in the field. As a result, the programme has identified that the fragmentation of both legal and institutional framework has led to the adoption of well-intended action occasioning unintended consequences for the oceans. Thus, the need for a new paradigm of ocean governance captured by this initiative is geared towards ensuring the establishment of effective ocean governance for the 21st century and beyond, as reiterated in Goal 14 of the UN 2030 Agenda for Sustainable Development.

ADVANCED DIPLOMA PROGRAMME IN INTERNATIONAL MARITIME LAW

The Advanced Diploma programme in International Maritime Law is designed to benefit professionals (including those at the most senior level) involved in maritime practice in both private and public sectors and who, because of their careers, are unable to be away from their jobs for a period of more than a few weeks / months per year.


The programme is structured on a credit system and, to be awarded the Advanced Diploma, candidates must earn a sufficient number of credits after successfully following and completing courses on distinct subject areas within either the Public International Maritime Law strand or the Private International Maritime Law strand. The credits offered broadly follow the subjects offered within the Institute's LL.M. programme. Candidates are required to have a degree from a recognized university or other academic institution, or must have a comparable standard qualification, including relevant professional or practical experience, or both, recognized for this purpose by the Institute. This programme can be undertaken between one and five years.

SPECIALIZED SHORT COURSES

The Institute's teaching in the Master's programmes is based on a modular system which enables a number of applicants to attend these modules as independent short courses. The duration of such courses ranges between one to several weeks, depending on the subject area. At the conclusion of each short course, a certificate of attendance is awarded. The specialized short courses have attracted, over the years, a large number of participants who are especially interested in the training the Institute offers in a particular area. On request of government entities, the Institute also organizes tailor-made specialized courses in areas of interest to government officials who register their participation.

Academic Year 2024-2025

On 2 October 2024, IMLI Welcomed its 36th Generation of **Lawvers and Maritime Professionals**

During the academic year 2024-2025, 48 students were enrolled in the LL.M. programme, 11 students in the M.Hum. programme and 1 student in the M.Phil. programme. These students hailed from 37 countries around the world. In addition, 3 students were enrolled in the Advanced Diploma Programme.

The academic year attracted 56 fellowships of which 31 were awarded to women candidates. During this year a total of 33 female students participated in the Institute's Master's programmes.

As in the previous academic years, the IMLI programmes were conducted in such a methodical and consistent manner demonstrating IMLI's commitment to its mission of educating and training fellows in international maritime law, to the highest academic standards.

During the period under review the Institute expanded its global outreach through the organisation of online specialized short courses for government officials in niche areas of international maritime law. These courses continued to be offered by the Institute in the reporting year and continued to be well attended by many in high-ranking officers including Permanent Representatives of the respective countries to the IMO, Ministers, Counsellors, Senior Foreign Officers, Government Officials and Maritime Professionals. They were exposed to the formidable body of work of the IMO in ensuring sustainable shipping for a sustainable planet and the vital role of other international organisations, courts, and tribunals in upholding the rule of international maritime law.
















Enrolment by Gender in the Institute's Master's Programmes in the Year 2023 - 2024

The IMLI Manual on International Maritime Law and The IMLI Treatise on Global Ocean Governance

Throughout 2024, "The IMLI Manual on International Maritime Law", published by Oxford University Press, continued to be regarded as an essential reference material for students, researchers, academics, and practitioners. The Manual provides a unique and comprehensive guide to all the major branches of international maritime law covering, in its three volumes, the Law of the Sea, Shipping Law, and Marine Environmental Law and Maritime Security Law, respectively. The Manual examines these fields from an international and comparative perspective and provides an in-depth analysis from the point of view of international conventions, customary law, and commercial practices.



The Book Series "IMLI Studies in International Maritime Law"

"The IMLI Treatise Global Ocean Governance" is an authoritative statement on the current state of the law on global ocean governance. Published by Oxford University Press, the Treatise is the product of the fruitful collaboration

between IMLI and The Nippon Foundation. In its three volumes, the Treatise deals with "The United Nations (UN) and Global Ocean Governance", "The UN Specialized Agencies and Global Ocean Governance", and "IMO and Global Ocean Governance", respectively. Fifty-eight leading experts, chosen on the basis of their eminence and expertise in the various areas covered by the Treatise, published contributions assessing the current state of the international regime regulating the use of the oceans to ensure that proposals for a new framework are based on reliable information.

The book series "IMLI Studies in International Maritime Law" published by Routledge simultaneously in London and New York, is dedicated to the publishing of original, scholarly

contributions that analyse key issues in international maritime law, which are of interest to an audience of students, scholars and practitioners in international maritime law. In 2023, the books entitled "Sea Level Change and Maritime Boundaries" by Dr. Antoine Grima and "Legal Aspects of Marine Protected Areas in the Mediterranean Sea: An Adriatic and Ionian Perspective" edited by Dr. Mitja Grbec, Professor Tullio Scovazzi, and Ass. Professor Ilaria Tani were published as part of the Series.



The Institute publishes a weekly electronic newsletter entitled IMLI e-News, featuring the latest updates on events including visits and presentations delivered by eminent personalities, Class academic exercises, Director's and faculty's engagements abroad as well as an advertising platform for all courses and initiatives.

The periodical IMLI e-News By the end of 2024, the Institute had published 25 issues of IMLI e-News,

17 issues of IMLI e-Alert, and issues No. 50 and No. 51 of the biannual IMLI News newsletter. Additionally, 350 online posts were shared via the "Happening Now" publishing tool and social media platforms including Facebook, LinkedIn, X (Twitter), Instagram, and YouTube. To further expand its reach, the IMLI Connect WhatsApp Chat Network was also utilized for this purpose reaching it to most of the over 1500 IMLI Graduates. 


To commemorate International Women's Day, IMLI also published a video containing affirming messages from female students at IMLI during the year under review.











Since its inception, IMLI has had the objective of enhancing capacity-building, especially in developing States. Recognizing that capacity-building is key in ensuring sustainable States' development, in particular, in its efforts to ensure an effective international maritime regime, IMLI has spearheaded numerous academic activities in the areas of international maritime law, particularly regarding the effective implementation of existing IMO regulations and prescriptions.







During the year 2024, IMLI delivered specialized courses on the Law of Ports, Seafarers' Rights, Protection of the Marine Environment and Ocean Governance, International Maritime Security Law, Law of Treaties as well as Peaceful Settlement of Maritime Disputes and Delimitation of Maritime Boundaries.

These specialized short courses, which may also be followed online, have enabled professionals who may not leave their countries to attend courses in the Institute's premises to enhance their knowledge

in all areas of international maritime law through IMLI's hybrid learning facilities. This has been the case for many country delegates to IMO who benefited from the free seats made available by the Institute. The free seat initiative was deeply appreciated by the Permanent Representatives of countries to IMO who applauded the Institute for its capacity-building efforts. These specialized courses have also contributed to the realization of IMLI's mission and to expand its global outreach.

IMLI COURSE ON THE LAW OF TREATIES

The IMLI Course on the Law of Treaties commenced on 4 November 2024. Professor Dr. Norman A. Martínez Gutiérrez (Director, IMLI) delivered the Introductory Address and Dr. David Nanopoulos (Chief, Treaty Section, Office of Legal Affairs, United Nations), delivered the Inaugural Address. Through an analysis of the provisions of the 1969 Vienna Convention on the Law of Treaties (VCLT) and developments found in jurisprudence and doctrine, this specialized Course provides, an overview of the Law of

Treaties with lectures discussing the relationship between treaties and customary international law, the States' expression of consent to be bound by treaties, treaty interpretation, third States and treaties, invalidity of treaties, methods of revision and amendment, duration

and termination, UN global and regional treaties for the oceans, and enforcement of treaties. The Course was complemented by lectures delivered by IMO officers on the IMO treaty-making process and the implementation of IMO instruments in national law, and other fundamental aspects of the Law of Treaties drawing examples from jurisprudence and the latest developments in this important area.

Among the participants, there were Ambassadors, Alternate Permanent Representatives of countries to IMO, Directors of Government Departments, and Diplomats, who were nominated by their respective Permanent Representatives to the IMO.

The Course covered various aspects of port operations, as well as several areas regulated by IMO legal instruments, including safety, security, marine environmental protection, and trade facilitation.



THE 35TH ANNIVERSARY CELEBRATIONS HELD AT IMO HEADQUARTERS IN LONDON

During the 111th Session of IMO Legal Committee, a celebration was held to commemorate the 35th Anniversary of the Institute. Mr. Domínguez continued his address by noting that over the past three

decades, IMLI has played a pivotal role in providing unparalleled legal training to over 1,700 maritime professionals from 160 States and territories.

These dedicated individuals, he noted further, representing diverse backgrounds, have become invaluable assets to their countries and the global maritime community. He recalled that since its inception, IMLI has remained steadfast in its commitment to diversity and inclusion by reserving 50 per cent of

seats for deserving female candidates. This dedication to gender equality, he stated, not only ensures equal access to education but also empowers women to thrive in the maritime industry, traditionally maledominated, enriching it with their unique talents. Mr. Domínguez said that he was pleased to highlight that two of the IMO Directors are IMLI Graduates. During his address, he also pledged his commitment to support the students through the IMO mentorship programme and encouraged others to do so as well.

Mr. Domínguez extended his deepest gratitude to the Government of Malta for being the welcoming and supportive host and commended the efforts of Professor Dr. Martínez Gutiérrez and his team for their dedication and service. He noted that their leadership and commitment to excellence have been instrumental in shaping IMLI into the renowned institution it is today.

IMLI'S 35TH ANNIVERSARY CONFERENCE



The Institute continued to celebrate its 35th Anniversary, by organising for the first time an International Conference entitled "Promoting the Implementation of IMO Objectives through Maritime Legislation". The Conference was organized in Collaboration with the Ministry for Foreign and European Affairs and Trade of Malta at the Mediterranean Conference Centre, Valletta on 17 June 2024.

The Welcoming Address was delivered by Professor Dr. Norman A. Martínez Gutiérrez (Director, IMLI), followed by the Keynote Address by Dr. Dorota Lost-Sieminska (Director, Legal Affairs and External Relations Division, IMO) on behalf of the IMO Secretary-General and Chairman of the IMLI Governing Board, Mr. Arsenio Domínguez. The Honourable Dr. Ian Borg (Minister for the then Ministry for Foreign and European Affairs and Trade, Malta) delivered the Concluding Remarks.

The Conference was attended by several eminent Speakers and guests, from all over the world, including IMLI Graduates as well as many distinguished personalities.

The subject matter of the Conference was discussed by six panels, each with four panellists and a moderator, tackling various crucial and contemporary topics as follows:


35TH ANNIVERSARY EXHIBITION

35th Annual Graduation 24 June 2024

The Institute held its 35th Graduation Ceremony on Saturday 29 June 2024. The Ceremony marked the successful completion of an intensive year of studies in all areas of international maritime law including the law of the sea, shipping law, marine environmental law and ocean governance, maritime safety and security law and maritime legislation drafting, and a number of workshops and seminars.

IMLI's simulcast Graduation Ceremony was presided over by Mr. Arsenio Domínguez (IMO Secretary-General, and Chairman, IMLI Governing Board) and was attended by many dignitaries, including Honourable Minister for Transport of Malta, the Officials from Ministries of the Maltese Government, Director of the IMO Technical Cooperation and Implementation Division, President of WMU, esteemed Donors, Head of REMPEC, Director of IIJ, Director General of the Continental Shelf Department, Chief Officer for Maritime Affairs at Transport Malta, Distinguished Visiting Fellows, Malta's State Advocate, Members of the Diplomatic Corps, Officials from University of Malta, and IMLI Graduates of previous years.

During the Ceremony, 69 students from 38 countries graduated from the Institute's various programmes. 50 students were awarded the Degree of Master of Laws (LL.M.) in International Maritime Law, 12 students were awarded the Degree of Master of Humanities (M.Hum.) in International Maritime Legislation and 7 students were awarded an Advanced Diploma in International Maritime Law. The 2024 Graduates now form part of an elite network of international maritime law specialists, who have also received sterling training at IMLI.

In his Welcoming Address, Professor Dr. Martínez Gutiérrez welcomed the dignitaries and guests to the Graduation Ceremony and stated that this year has been a remarkable year of many firsts and several milestones, which he went on to state in detail. The Director informed the audience that the graduating class is the largest class in IMLI's history and that they were the first to attend classes in the Institute's new state-of-art Auditorium (courtesy of the Government of Malta). The 2024 graduands, the Director observed, attended for the first time the meeting of the IMO Legal Committee since the field trip was organized for the first time during the academic year, and the first to attend the first ever international conference organized by the Institute.

LLOYD'S REGISTER FOUNDATION

Lloyd's Register Foundation was established to fund the advancement in transport, science, engineering, and technology education, training and research worldwide for the benefit of all, and to enhance the safety of life and property at sea, land and in the air. Since 2002, the Foundation has been generously funding nominated candidates to IMLI. In addition, it awards the LRF Prize for Best Performing Lloyd's Register Foundation Scholar to one of the three candidates who excels in the IMLI Masters' programmes. For the year 2024-2025, the LRF sponsored René Alberto Ruescas Mejía (Bolivia), Jacqueline Agyemang-Gyau (Ghana), and Aina Charity Shalonga Keshongo (Namibia).



AUSTRALIAN MARITIME SAFETY AUTHORITY (AMSA)

The Australian Maritime Safety Authority (AMSA) is the national regulatory body which promotes the safety and protection of the marine environment and combats ship sourced pollution. It provides the infrastructure for safety of navigation in Australian waters by maintaining national search and rescue services for the maritime and aviation sector. It also contributes to the continuous improvement and development of maritime safety, environmental management, and emergency response systems in the region. To this end, AMSA is keen to provide fellowships to IMLI, for the benefit of participants from countries located in the South Pacific. For the academic year 2024-2025, AMSA sponsored two students, Yabaki Vosadrau (Fiji) and Lloyd Fikiasi (Vanuatu).



EUROPEAN MARITIME SAFETY AUTHORITY (EMSA)

In 2023, the European Maritime Safety Agency (EMSA) awarded the Institute a contract for services in the amount of Euro 600,000. Through this contract, EMSA will sponsor the studies of suitable government officers from beneficiary countries, in the Institute's masters' and research degree programmes. For the academic year 2024-2025, EMSA sponsored Ramida Ismayilova (Azerbaijan), Ahmad Bassam Alfaraheed (Jordan), and Btissam Maaras (Morocco) to pursue studies in the Institute's master programmes.



INTERNATIONAL GROUP OF P&I CLUBS

The International Group of P&I Clubs, comprising of thirteen P&I Clubs between them, provides marine liability cover (protection and indemnity) for approximately 90% of the world's ocean-going tonnage. The aim of this Group includes, inter alia, promoting insurance related interests of shipping companies through a unified and collective voice. The Group has been supporting IMLI through fellowships and, for this academic year, enabled the studies of Switle Mae Tamang (the Philippines).



INTERNATIONAL CHAMBER OF SHIPPING

The International Chamber of Shipping is the global trade association for shipowners and operators which represents the world's national shipowner associations, and over 80% of the world merchant fleet. A long-standing supporter of IMLI, the Chamber extended its collaboration with the Institute this academic year through the provision of a fellowship to Florence Nuamaa Darko (Ghana).

NATIONAL GOVERNMENTS

For the academic year 2024-2025, the Government of Malaysia supported IMLI through the provision of two full fellowships. The recipients of these fellowships are Patterson Nyenati Blamo (Liberia) and Mohamed Ansari Dicritan (the Philippines). The Government of the Republic of Korea continues to support the studies of government nominated officers. Their generous funding enabled the training of Rajin Wickrama Gooneratne (Sri Lanka) and Mcphyson Ndibalema (the United Republic of Tanzania) at IMLI for the academic year 2024-2025. The Government of Nigeria sponsored the training of three Government Officials from Nigeria, namely Yvonne Binitie, Diwari Kelvin Peterside and Gambo Ado Gezawa. The National Centre for Environmental Compliance of Saudi Arabia sponsored the studies of Omar Mahal Almohammadi and Abdulaziz Alsaif. The Mexican Navy sponsored for the first time the studies of one of its officers, Alberto Hernández Gastelú. Other government entities also funded the studies of their officers, such as the Tanzania Ports Authority which sponsored the training of Mussa Jacobo Luhiso; the Indian Navy sponsored Prashant Bhatt; the Indian Coastguard sponsored Asha Dahiya; and the Italian Coastguard sponsored Pietro Vicedomini. Further, the Kingdom of the Netherlands sponsored the studies of Pälvi Parisius from Curaçao. IMLI is also grateful to the Government of Malta for its continued and dedicated support.



The Institute has steadily built up its Fund Balances and Reserves attributed to the surplus generated over the years since inception, which is transferred to form part of the Fund Balances and Reserves.

The Fund Balances and Reserves of EUR5.46 million as at 31 December 2024, can cover 211.9% or 25.4 months of sustainable operational support of the Institute.

The external auditor of IMO, *The Audit Board of the Republic of Indonesia* (BPK), is also the external auditor of the Institute. Following the external audit of the Institute's financial statements for the year ending 31 December 2024, the external auditor has expressed an umodified audit opinion. Moreover, in the Long-Form Report, the external auditor declared that overall, the key financial indicators of the Institute remain sound and that an analysis of the key financial ratios demonstrates that the Institute has the ability to meet all its liabilities.

The above figures are as per the Institute's audited financial statements. Following the adoption of International Public Sector Accounting Standard (IPSAS) 41 - Financial Instruments on its effective date 1 January 2023, the amounts for the year 2022 were restated where applicable due to the retrospective application required by this IPSAS.
